AN ACCOUNT OF GENOCIDE, ATROCITIES AND GROSS VIOLATION
OF HUMAN RIGHTS IN THE CHITTAGONG HILL TRACTS
BY BANGLADESH FORCES. FROM SEPTEMBER, 1986 TO NOVEMBER, 1986.

- I. 8 SEPT. 1986 Mr. Jyotirindra Kishore Chakma(Alias Angada Ranjan), 50 yrs, was arrested and taken to army custody by the Camp Commander of Bangladesh army Camp at Chongra Chari. Since then he is being detained under army Custody and subjected to tortures.
 - 13 SEPT.1986 Commander of the Bangladesh army Camp at Chongra Chari, P.S.(Police Station) Herung, called a meeting which was attended by a number of Jumma people. But after the meeting was over, the Commander arrested the following innocent persons -
- 2. Mr. Pramod Chakma, of Lamba Chara, P.S. Merung. After being arrested, he was inhumanly beaten and tortured for informations about the Shanti Bahini.
- 3. Mr. Kamini Kumar Chakma, a teacher, address -do- . As above.
- 4. Mr. Sugriv Chakma, address -do-, a leader of No. 2 Rubber Plantation. As above.
- 5. I3 SEPT.1986 Mr. Brisha Ketu Chakma, 52 yrs, son of late Gupta Moni Chakma, of Hetmora(North), P.S. Nania Char, was arrested by the army personnel from the army Camp at Burighat. He was tortured inhumanly during interrogations.
 - I5 SEPT.1986 The authorities of the Bangladesh army Camp at Chongra Charl, arrested the following innocent persons and subjected them with inhuman tortures during interrogations -
- 6. Mr. Prasanna Kumar Chakma, son of Mr. Binny Mohan Chakma, of Jalbanda Purna Sen Karbari Para, P.S. Merung.
- 7. Mr. Biding Chakma, son of Mr. Deva Priya Chakma, address -do- .
- 8. Mr. Proti Sobha Chakma, son of Mr. Chandu Chakma, address -do- .
 - I5 SEPT.I986 A group of 25 soldiers from 42 EBR(East Bengal Regiment), Bangladesh army, led by a Captain from the army Camp at Thalchara, carried out operations against the Jumma village Bakchari, P.S. Nania Char, during which the army personnel resorted to looting and victimised the following innocent persons -
- 9. Mr. Juronya Chakma, 35 yrs, son of Mr. Kalashesh Chakma, of Bakchari, P.S. Nania Char. The soldiers looted away 5 fowls from him.

IO. Mr. Pradon Chandra Chakma, 40 yrs, son of Mr. Rangashesh Chakma, of Bakchari, P.S. Nania Char. He was compelled to give 7 coconuts to the soldiers free of cost.

- II. Mr. Umakanta Chakma, 33 yrs, son of Mr. Balaram Chakma, address -do- . The soldiers looted away 6 fowls from him.
- 12. Mr. Raj Chandra Chakma, 30 yrs, son of Mr. Zuro Dhon Chakma, address -do- . The soldiers looted away 4 fowls from him.

- 14. Mr. Bindu Lal Chakma, 40 yrs, son of Mr. Pong Chan Chakma, of Mubachari, Banduk Bhanga Union, P.S. Kotwali. He was arrested and beaten severely. The soldiers looted away Tk. 1000/-(One thousand taka) and 3 quintals of paddy from him.
- 15. Mr. Chanchal Chakma, 30 yrs, son of Mr. Balaram Chakma, address -do- . He was arrested and beaten severely. The soldiers looted away Tk. 1500/-(One thousand and five hundred taka) from him.
- I6. Mr. Bipuleshwar Chakma, 28 yrs, son of Mr. Ramani Chakma, address -do- . He was arrested and beaten. The soldiers looted away Tk.500/-(Five hundred taka) from him.
- 17. Mr. Chandra Raj Chakma, 26 yrs, son of Mr. Dhirasen Chakma, address -do- . As above. The soldiers looted away Tk. I200/-(One thousand and two hundred taka) from him.
- 18. Mr. Kripa Charan Chakma, 37 yrs, son of Mr. Chandra Mohan Chakma, address -do- . As above. The soldiers looted away Tk. I400/-(One thousand and four hundred taka) from him.
- 19. Mr. Suresh Chandra Chakma, 52 yrs, son of Mr. Mahendra Chandra Chakma, address -do- . As above. The soldiers looted away Tk. II50/-(One thousand, one hundred and fifty taka) from him.
- 20. Mr. Vriga Moni Chakma, son of Mr. Vrisha Ketu Chakma, address -do- . The soldiers looted 6 quintals of paddy from him.
- 2I. Mr. Vrisha Ketu Chakma, son of Mr. Surojoy Chakma, address -do- . The soldiers looted away 8 quintals of paddy from him.

They were returning home from Dighinala, on the way they were caught by the army personnel. Mr. Kina Dhon Chakma was brutally murdered and Mrs. Badimila Chakma was barbarously gang raped by the soldiers. She had to take refuge in the Tripura State, India, with her parents and presently sheltered at Karbook Refugee Camp, South Tripura.
- 41. I OCT.1986 Mr. Muni Chakma, 27 yrs, son of Mr. Achyut Ranjan Chakma, of Shon Khola Para, P.S. Nania Char, was arrested by the army personnel at Rangamati. He is being kept under army custody.
 - 6 OCT.1986 Major Bari and soldiers of 4I EBR, Bangladesh army, from the army Camp at Karengatuli, raided the Jumma villages Kozu Chara and Bhuiyo Chara, P.S. Baghai Chari.
