- d) Twisting and spraining of linger joints and the wrists so that the victim remains crippled for ever. This torture applied on the young and able bodied persons;

e) Putting off cigarete buds on the body;

- Hanging upside down and beating the victim till fainting:
- g) Beating the victim indiscriminately with wooden blocks. sticks, bamboos, canes, ropes, iron rods what-ever available infront of them;
- 1) Undressing men and women enmasse and carrying away the Jumma women into the army camps in nude where they are raped for days and nights;
- i) Arresting men and women enmasse and kept in detention;
- j) Mass and gang raping of Jumma women by Bangladesh forces and muslim infiltrators;
- k) Arbitrary arrests and kept in detention: tortured with electric shock on the genitals; kept in pits without food and water; squeezing of testicles, hanging by one hand, kicking like football, putting inside, gunny bags and dipping in water, made to look at, powerful

lights for hours etc.
