Sub: An appeal to save the Chakma and other tribes of the
Chittagong Hill Tracts from the total annihilation by
the Bangladesh Government.

Dear Brother,

May I present to you a report, "Atrocities committed on the innocent tribal people of Chittagong Hill Tracts by Bangladesh Army, Bangla Desh Rifles (BDR), Armed Police Battalion (APB), Ansars and Village Defence Party (VDP) from January 1986 to April 1986", sent by the Jana Samhati Samiti on May 24, 1986.

The report shows 215 cases of racial, religious and genocidal violence committed by the Bangladeshi regime against the innocent indigenous people of the Chittagong Hill Tracts (CHT) with exceptional cruelty and inhumanity. On the orders of the highest authorities of Bangladesh, the Bangladesh armed forces and Bengali settlers persecute the CHT people, attack their places of worship, relocate them in concentration camps, rape their women, torture them systematically, steal their lands and valuables, and detain them without charge or trial on the grounds that they are non-Bengalis, non-Muslims and of Tibeto-Burman culture.

A. RELIGIOUS PERSECUTION

1. On 28th January 1986, at 0400 hrs, Captain Bayzid (13 East Bengal Regiment, Bangladesh Army) and his troops from Kyang Ghat camp surrounded the village of Krishna Chara Para in Mohal Chari Upazilla (Sub-District), assembled the villagers in a field, and forced them to pray to ALLAH by reciting the hymn, ALLAH-O-AKBAR, three times. After the prayer was over, the Bengali officer asked them to embrace Islam and told them that they would be provided with financial help and beautiful mosques if they embraced Islam. He also emphasized that if they did not do so then they must leave for India. Captain Bayzid said to the villagers, "There is no room for KAFIRS (non-believers of Islam). The people of the CHT are KAFIRS. So it is our sacred duty to Islamise CHT and INSHA ALLAH (by the Grace of God) we will be successful."
2. On 18th February 1986, at 1100/1200 hrs, Major A. Kalam and his soldiers (29 East Bengal Regiment, Bangladesh Army) from Madhya Para camp in Bandhuk Bhangra within Rangamati Upazilla set fire to the Tripura Chara Bana Vihar (temple). This temple has a special spiritual importance as it was dedicated to the greatest Buddhist monk in the CHT, Rev. Sashana Nanda Mahathero (popularly known as Bono Bhante because he meditates in the forest). The attack on such a holy place offended the public immensely. So on 27th Feb. 1986, on behalf of the community, Mr. Hridoy Ranjan Chakma, a Member of the Union Council, went to the Army camp to protest at this barbaric attack. No action was taken against the culprits. Instead he was beaten severely by a Subedar (junior commissioned officer) and told, "Islam we want and not your bloody Buddhist temple. We want Islam not only in CHT but we want also the whole world as Islamic world."
3. On 5th and 6th February 1986, Lt. Jaglul (13 East Bengal Regiment, Bangladesh Army) and Bengali soldiers from Silban camp rounded up the inhabitants of Madhya Adam (village) in Mohal Chari Upazilla, took them to Madhya Adam Buddhist temple and subjected them to mass torture and rape. For example, Mr. Dharendra Lal Karbari, 64, son of late Raj Sen Chakma, was beaten severely, hung upside down on a tree, and had water forced through his nose and mouth. Mrs.

4. On 12th March 1986, Mr. Sukhamoy Chakma, 22, son of Mera Singh Chakma, of Latiban village in Panchari Upazilla, was shot dead in the vicinity of Panchari Buddhist temple by the army personnel of Panchari camp.

B. RELOCATION OF INDIGENOUS FARMERS IN CONCENTRATION CAMPS

The Bangladesh Government depopulate the tribal villages by herding the farmers in concentration camps in order to settle the Bengali settlers in their place. These camps are described as model villages, co-operative farming projects and strategic villages with a view to hiding extremely terrifying conditions in them. Murder, beating, torture, rape, starvation, lack of medical care and degrading harassment are commonplace in the concentration camps under the Bangladesh armed forces. The villagers are terrorized to leave their ancestral villages and farmlands. For example,

1. On 14th January 1986, the members of the Bangladesh Army (13 East Bengal Regiment from Silban camp) attacked the village of Satghar Para in Mohal Chari Upazilla, beat the villagers severely, burnt all their houses, destroyed all their properties, and took them to a nearby concentration camp at Dhela Para at gun point against their will.
2. On 17th February 1986, the inhabitants of Bazey Chara Adam (village), Tara Chari Adam and Haza Chara Adam in Nania Char Upazilla were taken forcibly to the concentration camp near the village of Jyotirmoy Headman Para in Kengel Chari within Mohal Chari Upazilla.
3. Khagra Para (village) & Tanakka Para in Panchari Upazilla, and Deno Assalong Para in Matiranga Upazilla were completely destroyed by the Bangladesh Army on 18th and 23rd Feb. 1986 respectively. These villagers were forcibly taken to the Bhaibon Chara concentration camp in the Panchari Upazilla (the report sent by the JSS on 10.5.86).

C. RAPE

The personnel of the Bangladesh armed forces and the Bengali settlers rape the indigenous women in order to assimilate the CHT people as part of the Bangladeshi regime's secret plan to destroy the identity of the of the CHT. A few examples are given below.

1. On 2nd April 1986, at 0700 hrs, Major Shahjahan (also known as the butcher of the Kalampati or Kaokhali massacres of 1980) and his soldiers (19 East Bengal Regiment, Bangladesh Army) from Panchari camp rounded up all inhabitants of Gunadhar Karbari Para (village) in Jugal Chari Mouza within Panchari Upazilla, and divided them into 2 groups - male and female. The Bengali commander selected 3 young women and 1 young girl for himself and then ordered his men to attack the remaining captives. The men were beaten ruthlessly and the women were raped whole night. Miss Kalpana Devi Chakma, 18, daughter of Mr. Kalabagya Chakma, two daughters-in-law of Mr. Kalabagya Chakma, and the daughter-in-law of Mr. Bipin Chandra Chakma were among the victims of rape.
2. On 19th April 1986, the army men and the commander of Gaganpara (Dhanpata) camp attacked the villagers of Narai Chari in Dighinala Upazilla, beat them mercilessly, burnt their houses, stole their stocks and valuables, raped their women, and took them to the army camp. Mrs. Ittuki Chakma, 19, wife of Mr. Gunadhar Chakma, and Miss Shanka Bala Chakma, 16, daughter of Mr. Lekhya Dhon Chakma, and many others are still being kept in the army camp without trial.
3. On 21st January 1986, at 0330 hrs, Captain Bayzid (13 East Bengal Regiment, Bangladesh Army) led a combined force of the Army men and the Ansars (Islamic Guards) from Kyang Ghat and Dumoni Ghat camps to raid the village of Muniram Karbari Para in Mohal Chari Upazilla. The invaders committed atrocities on the villagers, stole their stocks and money, and raped their women. For instance, Mrs. Dhira Tripura, 22, wife of Mr. Anta Singh Tripura was raped by 5 army men. Mrs. Champa Phul Tripura, 19, wife of Mr. Kachi Mohan Tripura, was also raped in front of her husband.

D. TORTURE

1. On 4th March 1986, at 2300 hrs, Major Akhtar and his troops (203 Brigade, East Bengal Regiment from Khagrachari camp) attacked the village of Rangapani Chara in Khagrachari Upazilla and arrested six people - i) Mr. Nayan Jyoti Chakma, 26, son of Mr. Angada Kumar Chakma, ii) Mr. Nirmal Kanti Chakma, 22, son of Mr. Nishi Mohan Chakma, iii) Mr. Amrita Lal Chakma, 38, son of Mr. Urajoy Chakma, iv) Mr. Uchitmoy Chakma, 30, son of Mr. Kisto Lal Chakma, v) Mr. Dipokya Bap Chakma, 37, son of Mr. Gopjoy Chakma, and vi) Mr. Mohin Bikash Chakma, 45, son of Mr. Indra Kumar Chakma and a teacher of Harinath Para Primary School -, and took them to Khagrachari camp for interrogation. They were beaten, tortured with electric shocks, and water was forced through their noses and mouths during interrogation and they are still being detained without charge or trial.
2. On 17th February 1986, Subedar Barek of the Bangladesh Army from Guimara camp beat Mr. Arun Bikash Chakma, 30, son of Mr. Hirendra Lal Chakma, of Betchari Mukh village in Nania Chari Upazilla, and Mr. Anil Chandra Chakma, 28, son of Mr. Jarani Mohan Chakma, of Son Khola Para in Nania Chari Upazilla inhumanly and subjected them to various forms of torture.
3. On 23rd February 1986, an army unit from Guimara Zone raided Korolya Chari and Jogonatuli villages. The villagers were beaten and tortured with electric shocks, and women were raped during interrogation. For instance, Mr. Chiyona Chakma, 70, son of Mr. Kinaram Chakma, of Jogonatuli was beaten so severely that he became unconscious. Miss Laxmi Devi Chakma, 20, daughter of Mr. Makkyia Dhon Chakma, of Korolya Chari, was gang-raped in front of her father.

E. ROBBERY

1. On 14th February 1986, at 2400 hrs, the army men (13 East Bengal Regiment, Bangladesh Army) from Betchari camp rounded up i) Mr. Sobhadhan Chakma, 45, son of Mr. Punya Sen Chakma, ii) Mr. Prabhat Chandra Chakma, 48, son of Mr. Raja Ram Chakma, iii) Mr. Gopendra Chakma, 55, son of Mr. Chandra Dhar Chakma, all of inner Betchari Para (village) in Khagrachari Upazilla, tortured them and forced them to pay Taka 1500/-, Taka 2000/-, and Taka 2400/- respectively.
2. On 27th January 1986, a unit of the Bangladesh Army (30th East Bengal Regiment) raided the house of Mr. Bashi Chakma, 42, son of late Robi Chandra Karbari, of Madhya Manik Chari Para (village) in Mohal Chari Upazilla, beat him, forced water through his nose and mouth, looted his valuable belongings including Taka 4000/-, and stole his fowls. They also tortured another villager, Mr. Lalya Chakma, 45, son of late Robi Chandra Karbari, and forced him to give them a bullock and 2 goats free of cost for their meals.

Under the instructions of the military rulers of Bangladesh, the indigenous people of the CHT are massacred and tortured, their villages and farmlands are seized for the Bengali settlers, their women are raped, their temples are desecrated and destroyed, and their religions and cultures are attacked by the Bangladesh armed forces. On the other hand the CHT people are being forced to become Muslims. The military junta has declared again and again that if the indigenous people of the CHT do not embrace Islam then they will be either exterminated or pushed out of the CHT. It is becoming increasingly difficult for the CHT people to survive in their own traditional homeland. I, therefore, appeal fervently to you to expel the brutal invaders from the CHT. ATROCITIES COMMITTED ON THE INNOCENT TRIBAL PEOPLE OF CHITTAGONG HILL TRACTS BY BANGLADESH ARMY, BANGLADESH RIFLES (BDR), ARMED POLICE BATTALION (APB), ANSARS AND VILLAGE DEFENCE PARTY (VDP) FROM JANUARY 1986 TO APRIL 1986.

On 6th January, 1986, a unit of 305 Brigade, Bangladesh Army from Bogachari army camp, raided the village of Bajey Chara, P.S. Nania Char, committing atrocities, beating and raping men and women. The victims are :-

1. Roshik Kumar Chakma, 35, son of Indra Mohan Chakma, of Bajey Chara, P.S. Nania Char.
2. Kandara Chakma, 27, son of Kinaram Chakma, of Bajey Chara, P.S. Nania Char.
3. Tipu Ranjan Chakma, 20, son of Sama Ranjan Chakma, of Bajey Chara, P.S. Nania Char.
4. Ban Chandra Chakma, 60, of Bajey Chara, P.S. Nania Char.
5. Mrs. Ban Chandra Chakma, 54, wife of Ban Chandra Chakma, of Bajey Chara, P.S. Nania Char.
6. Indra Shova Chakma, 22, daughter of Banchandra Chakma, of Bajey Chara P.S. Nania Char, was raped.
7. Nihar Bala Chakma, 30, wife of Dharendra Chakma, of Bajey Chara, P.S. Nania Char, was raped brutally.

On 6th January, 1986, the same unit from Bogachari army camp, raided the village of Haza Chari, P.S. Nania Char, beating and torturing the inhabitants including the Karbari (village Head) of the village. The names of the victims are given below :-

8. Nirananda Chakma, 53, son of Kali Kumar Chakma, Karbari (village Head) of Haza Chari, P.S. Nania Char, was beaten severely.
9. Sonadhon Chakma, 45, son of Kalachan Chakma, of Haza Chari, P.S. Nania Char.
10. vira Kumar Chakma, 55, son of Subal Chandra Chakma, of Hazachari, P.S. Nania Char.
11. Sneha Kumar Chakma, 35, son of Panya Choga Chakma, of Hazachari, P.S. Nania Char.
12. Ranga Choga Chakma, 46, son of Kalya Chakma, of Hazachari, P.S. Nania Char.
13. Rosik Kumar Chakma, 40, son of Kala Chan Chakma, of Hazachari, P.S.

14. Modan Mohan Chakma, 60, son of Raj Kumar Chakma, of Hazachari, P.S. Nania Char.

On 8th January, 1986, operations were carried out in the villages—Kamal Chari, Tanyama Chara, Shakra Chara, inner Betchari Para and Betchari Thoom Para by three army units of 203 Brigade, Bangladesh Army, Khagra Chari, contonment. The units stayed at inner Betchari Para and left for Khagrachari on 10th January, 1986. During their stay, the following persons were compelled to give them rice and fowls, goat free of east :-

17. Proti Kumar Chakma, 32, son of Joyot Dhar Karbari, of inner Betchari Para, P.S. Khagrachari, had to give four fowls and one quintal of rice to the army personnels.
18. Lalit Mohan Chakma, 34, son of Ratnadhar Chakma, of inner Betchari Para, P.S. Khagrachari, ~~had to give~~ was forced to give the army personnels two goats free of cost.

On 12th January, 1986, houses of two tribal men of Chongra Chari, P.S. ~~were~~ Rangamati were burnt down by army personnels.

19. Krishna Chandra Chakma, 35, son of Hima Hejya Chakma of Chongra Chari, P.S. Rangamati.
20. Bishnu Chakma, 37, son of Manudhan Chakma, of Chongra Chari, P.S. Rangamati.

On 14th January, 1986, the ~~village~~ village named Satghar Para, P.S. Mohal Chari, was burnt to ashes by army personnels of 13, East Bengal Regiment from Silban camp, after taking the tribal inhabitants into a grouping area at Dhela Para, P.S. Mohal Chari, by force against their will. All their properties were destroyed and they were beaten mercilessly. Below the names of persons whose houses were burnt are given:-

On 21st January, 1986, a combined force consisting of Ansars (Islamic guards) and army of 13, East Bengal Regiment, Bangladesh army of Kyang Ghat camp and Dumoni Ghat camp, led by Captain Bayzid, rounded the tribal village of Muniram Karbari Para, P.S. Mohal Chari, at 0330 hrs BST (2230 Hrs, GMT) creating reign of terror and committed atrocities on the innocent rribalmen and raping women, looted their belongings and movable properties— such as, goats, fowls, rice, money gold etc. The names of the victims are given below:-

41. Moniram Karbari, 55, son of Saro Chandra Tripura, of Muniram Karbari Para, P.S. Mohal Chari, was beaten for cooperation with JSS. 3 fowls and a goat was taken away from him without paument.
42. Sompa Charan Tripura, 65, son of late Rupaya Tripura, of Muniram Karbari Para, P.S. Mohal Chari, was beaten.
43. Najendra Tripura, 30, son of Muji Mohan Tripura, of Muniram Karbari Para, P.S. Mohal Chari, was severely beaten and had water poured through the nose and mouth till he became senseless. Taka 1000/- (one thousand) was looted from him.
44. Majendra Tripura, 32, son of Priti Tripura, of Muriram Karbari Para, P.S. Mohal Chari, was beaten with rifle butts and kicked left and right.
45. Golap Phul Tripura, 24, wife of Barajoy Tripura, of Muniram Karbari Para, P.S. Mohal Chari, was raped infront of her husband who was tied with a rope.
46. Dhira Tripura, 22, wife of Anta Singh Tripura, of Muniram Karbari Para, P.S. Mohal Chari, was raped by five army personnels who kicked her husband out of the house.
47. Champa Phul Tripura, 19, wife of Kachi Mohan Tripura, of Muniram Karbari Para, P.S. Mohal Chari, was also gang raped in her house infront of her husnand.
48. Kanta Singh Tripura, 30, son of Kanta kai Tripura, of Muniram Karbari Para, P.S. Mohal Chari, was beaten severely. One quintal of rice was taken from him by force without payment.
49. Naji Kumar Tripura, 26, son of Moyero Tripura, of Muniram Para, P.S. Mohal Chari, was kicked left and right . One goat was taken away from him without payment.

50. Virendra Tripura, 25, son of Ratna Kumar Tripura, of Muniram Karbari Para, P.S. Mohal Chari, was beaten mercilessly and abused filthily. He was compelled to give 13 fowls free of cost.
 51. Ratna Kumar Tripura, 70, son of late Temang Tripura, of Muniram Karbari Para, P.S. Mohal Chari, was made naked and paraded and told "If you get right of self-determination all the people of CHT will be like this."
 52. On 21st January, 1986, the army unit from Kyang ghat camp, raided the village of Roshidhon Karbari Para, P.S. Mohal Chari, at 1700hrs.BST (1100 hrs. GMT) committing atrocities, rape and looting money. Names of the victims are given below :-
 52. Joly Mohan Tripura, 15, son of Uttari Tripura, of Roshidhon Karbari Para, P.S. Mohal Chari, was caned twenty times and told that if he would join the Shanti Bahini he would be shot dead.
 53. Pabchai Tripura, 23, son of Roshidhon Karbari, ~~Para~~, of Roshidhon Karbari Para, P.S. Mohal Chari, was hung up side down and beaten severely. The army personnes looted taka 1000/- (one thousand) from him. Took 4 fowls forcefully without payment.
 54. Miss. Jestu Moti Tripura, 17, daughter of Nalin Kumar Tripura, of Roshidhon Karbari Para, P.S. Mohal Chari, was raped by six army personnels.
- 25th January, 1986, a unit of 30th East Bengal Regiment, Bangladesh army carried out operations in Plantation areas of No5 project under Longudu, police station. The army personnels beat mercilessly tortured physically and poured water through the mouth and nose on these victims :-

61. On 26th January, 1986, the same army unit arrested Satish Chandra Chakma 35, son of Larma Kochya, Lower Manik Chari Para, P.S. Mohal Chari. He is the Karbari (village Head) of lower Manik Chari Para, He was beaten and tortured in himanly . Four fowls were taken forcefully without payment.

He was poured ~~wat~~ water through the nose and mouth and beaten severely.

which the Chakma people profess. When Mr. Hridoy Ranjan Chakma, M a member of the Union council on behalf of the local people went to protest and complain at the army camp about this barbaric act, he was beaten mercilessly at the camp by a Subedar (a junior ~~XXXXX~~ commissioned officer) on 27~~th~~ February, 1986 at about 0900/1000 hrs BST (0300/0400hrs GMT). He was told while he was being beaten that "Islam we want and not your bloody Buddhist temple. We want Islam not only in CHT, we want the whole world as Islamic world." Soldiers of the said camp are forcibly taing cattles, fowls, rice from the inhabitants of Tripura Chara and Bandhuk Bhangra without payment although they are supplied ration from the govt. which they sell in the black market run by the Bangali Muslims. For instance, on 22nd February, 1986, inhabitants of Tripura Chara had to purchase a bullock for Tk. 4000/- for the soldiers of the camp for their sumptuous meal.

On 18th February, 1986, army units of Tintilla Zone, P.S. Longudu, carried out operations in the Chakma villges of Kosolya Chari, Deno Longudu, Longudu Mohajan Para, P.S. Longudu, beating indiscriminately and subjecting the innocent inhanitants to inhuman tortures. Below the victims name are funished:

On 6th March, 1986, a army unit from Guimara Zone of 203 Brigade East Bengal Rangiment , Bangaldesh army, on a pretext of holding a ~~meeting~~ meeting with the inhabitants of Nakkua Para P.S. Matiranga , ordered the people to remain in their houses. Then the ~~meetingx~~ army unite instead of holding the meeting started house to house searches , looting beating and interrogation of men and raping women . Below the names of victims are given :

On 2nd April, 1986, at 0700hrs BST (0100hrs GMT) an army unit from under command of Major Shahjehan of 19 East Bangal Regiment , from Panchari army camp, surrounded the vilage --Gunadhar Karbari Para , Chota Panchari of No. 246, Jugal Chari Mouza, P.S. Panchari. All the inhabitants were gathered together and sorted out into two groups male and female. The army commander at 1000 hrs BST (0400 hrs. GMT) selected three young women and one young girl of his choice and gave orders to his men to swoop ~~in~~ down upon the rest of the ~~inhabitants~~ inhabitants. Man and women were bea en and raped. All the night women were raped. The unit left the vilage next day on 3rd April, 1986, at 1700 hrs, BST (1100hrs. GMT) for Panchari army camp. Particular of victims ~~are given~~ are given below:

On 19th April, 1986, an army unit from Gagan Para (Dhanpata) camp, P.S. Dighinala, led by the camp commander, carried out operation in the hills where Chakmas made their shifting cultivation (Jhum). The army unit committed atrocities, arsoning on the innocent Chakmas, raped women, took men and women to the camp, looted Paddy, money and properties, Victims names are given below:

199. Sindhu Chandra Chakma (Goppua), 60, of Naraichari, Bajuchara union council, P.S. Dighinala, was beaten severely. Taka 1500/- (one thousand five hundred) was looted from him. He was taken to the camp and being kept under army custody without bail.
200. Ittuki Chakma, 19, wife of Gunadhar Chakma, of Narai Chari, Babuchara union council, P.S. Dighinala, was raped brutally and taken to the camp and being kept under army custody and being raped by the army personnels.
201. Shankha Bala Chakma, 16, daughter of Lekhya dhon Chakma, of Naraichari, Babuchara Union council, P.S. Dighinala, was gang raped and taken to the camp and being kept under army custody—where she is being subjected to inhuman raping.
