AN ACCOUNT OF GENOCIDE, ATROCITIES AND GROSS VICLATIONS OF HUMAN RIGHTS IN THE CHITTAGONG HILL TRACTS

BY BANGLADESH FORCES.

FROM DECEMBER, 1986 TO JANUARY, 1987.

I DEC. 1986 - Bangladesh army personnel from the army Camp at Baghai Khat, P.S. (Police Station) Dighinala, and illegal Bengalee Muslim infiltrators of Baghai Khat Bazar, killed 4(Four) Jumma persons of Korolya Chari Mukh of Baghai Khat, P.S. Dighinala. On the day of incident, these Jumma persons went to Baghai Khat Bazar for marketing. They were attacked by illegal Bengalee Muslim infiltrators of the market and one of the four Jummas was killed on the spot and three others managed to escape and took shelter at the army Camp where they were killed by the army personnel. Name of one of the four Jummas who were killed was available. He is -

- I. Mr. Robi Chan Chakma, of Korolya Chari Mukh, Baghai Khat, P.S. Dighinala.
 - 2 DEC. 1986 Soldiers of 20 EBR(East Bengal Regiment Infantry Rgt.), Bangladesh army, from the army Camp at Baghai Khat, during operations, killed two innocent Jumma persons and raped Jumma women enmasse in Baghai Khat, P.S. Dighinala.
 - 2 DEC. 1986 Soldiers of 19 EBR, Bangladesh army, under Panchari Zone, arrested two innocent Jumma persons who were subjected to severe physical tortures and were taken to the army Camp where they are still being detained. The victims are -

While beating the victim, the Lieutenant said "It matters nothing damn if creatures like you Kafirs(Non-believer of Islam but the term is used in the CHT by fundamentalist and fanatic Bangladesh forces to mean the Jumma people as hated beings) get killed in Bangladesh or go to bloody India. We will wash our hands with bloody Chakma blood. "He was beaten by the Lieutenant for one hour. He was

thrown into a ditch with his hands tied back on kneeling position. Then the soldiers jumped on him and kicked him. He became senseless due to inhuman torturing. The Lieutenant threatened him with shooting if he would not leave the village within two weeks time. He was given release at I300 hrs. BST. The victim is now a CHT Refugee in Tripura State, India and presently sheltered at Takumbari Refugee Camp, South Tripura. Marks of injury due to army torturing - His right hand fore finger fractured.

- II3. Mr. Protishodh Chakma, 48 yrs, son of late Kinaram Chakma. of Nuaram Karbari Para(Viswa Ram Karbari Para), Boal Khali, P.S. Dighinala. He is the Karbari(Village Head) of the village. He was also charged with Shanti Bahini members frequenting in his village by the Lieutenant. As he denied the charge, the Lieutenant hit him with a large stick and he fell on the ground. He was raised from the ground and beaten inhumanly with a large cane and whipped with a rope by an NCO called Alim Ustad (The term 'Ustad' is used for addressing an NCO by a soldier in Bangladesh army). He was beaten till he fainted. The Lieutenant said to the victim in a very degrading manner in these words, "It matters nothing if you people get killed or go to India. We want the land not you bloody tribals." The victim was compelled to give away the bullock of Mr. Nuaram Karbari to the Lieutenant and the soldiers free of cost for slaughter. He was given release at I300 hrs. BST. The victim had to cross the international border for security of life. He is now a refugee in India, presently sheltered at Takumbari Refugee Camp, South Tripura, India. Marks of injury - Beating marks on the back.
- II4. Mr. Dino Bandhu Chakma, 35 yrs, son of Mr. Bhakta Chakma, address -do- .. During the interrogations, he was tortured so much that he fainted twice. The Lieutenant abused him in filthy terms, such as - SHALA (Brother-in-law, that means the Lieutenant marries the sister of the victim). Although he was totally innocent and had nothing to do with Shanti Bahini activities, hot water was sprinkled on him to make a confession which he had to do in order to save himself from being inhumanly tortured. During interrogations, a bucket of water was forced through his nose and mouth till he fainted. The Lieutenant gave him two weeks time to leave the village or else he would be shot dead. The victim, having no security of life in the CHT due to army atrocity, had to cross the international border to seek refuge in India on 15 JAN.1987 and was registered as a CHT Refugee in Tripura State, India on 16 JAN. 1987. He is presently sheltered at Takumbari Refugee Camp, South Tripura, India. Marks of injury - Beating marks and burns of hot water on his back are prominent.
- II5. Master Uttor Moni Chakma, I6 yrs, son of Mr. Protishodh Chakma, address -do-. The victim was beaten and tortured by the same Lieutenant. During the interrogations, when he said that he had nothing to do with Shanti Bahini activities, he was stripped of his clothes and then he was inhumanly beaten and was kicked like a foot ball

19 JAN. 1987 - Major Kader and 190 soldiers of 19 EBR, Bangladesh army, from the army Camps at Nalkaba and Bhaibon Chara, carried out operations against landless Jumma people who have been rehabilitated in No. 2 Rehabilitation Area under Panchari, at I600 hrs. BST. During the operations, many Jumma men and women were subjected to inhuman beating, tortures and rape. To mention here that Bangladesh government with the help and financial assistance from the Asian Development Bank(ADB), under the guise of Hill Tracts Development Programme, has nominally rehabilitated the landless slash and burn Jumma cultivators in this area only to deceive the international Community. In reality, the Jumma people who were rehabilitated here, had to bear more sufferings at the hands of Bangladesh army personnel and illegal Bengalee Muslim infiltrators who persecuted them since their rehabilitation. In the name of rehabilitation of the landless Jumma people and the Development Programme for CHT, Bangladesh government has received financial assistance and loan from ADB the lion share of which has been spent for the illegal settlement of Bengalee Muslim infiltrators in the CHT. The aim of the operations was to uproot the Jumma people from this Rehabilitation Area in order to settle the illegal Muslim infiltrators. The victims of army atrocities -
