ACCOUNT OF ATROCITIES, LOOTING, ARSONING, ARRESTS, MURDER & RAPE COMMITTED ON THE JUMMA PEOPLE OF CHITTAGONG HILL TRACTS BY BANGLADESH ARMY, PARA-MILITARY FORCES & BENGALI MUSLIM INFILTRATORS (FROM JANUARY, 1989-DECEMBER, 1989). - (Sent by the Jana Samhati Samiti on 22 June, 1990).

01 Jan. 1989 - An innocent Jumma student who was going back to his college from his home after vacation, was arrested on a false charge of being a Shanti Bahini at Matiranga Police Station. After being arrested by the police, the victim was tortured during interrogation. The victim is being kept without trial at Khagrachari jail. Particulars of the victim -

1. Mr. Bimal Chandra Chakma, 20 yrs, son of Mr. Kamini Kumar Chakma, of Pabla Khali, No. 51 Dighinala Mouza, P.S. Dighinala. The victim is a 1st yr. student of Intermediate (Arts), Hat Hazari College, Chittagong.

05 Jan. 1989 - Capt. Aleem and Lt. Maisuddin of 31 East Bengal Regiment, Bangladesh Army, from the army at Kuki Chara, P.S. Khagrachari, raided the Jumma village - Baura Para, No. 238 Gasban Mouza, P.S. Khagrachari. The following innocent persons were arrested from their houses on false allegation of helping the Shanti Bahini. They were taken to the Zonal HQ at Khagrachari where they were subjected to inhuman tortures during interrogation. The victims are -

06 Jan. 1989 - Lt. Col. Bazlur Rahman, Commanding Officer of Dighinala Cantonment and soldiers of 6 East Bengal Regiment, during an operation against the Jumma inhabitants of Tebang Chara and Baghai Chari, P.S. Dighinala, subjected the innocent people to inhuman beating, tortures and arrests. The victims are -

08 Jan. 1989 - An innocent Jumma labourer was killed by a police van on Khagrachari-Rangamati Road. The driver, constable Abdul Mannan was driving the van having No. Chatta (N) 2711. The police driver without giving horn, straight away drove on the innocent victim from behind. The act was done intentionally. No action was taken against the police constable by Kotwali Police Station, Rangamati. No compensation was given to the deceased's

13. Mr. Ranga Mua Chakma, 65 yrs, son of Mr. Naga Chakma, of Sukar Chari Kamar Para, No. 110 Sukar Chari Mouza, P.S. Kotwali.

10 Jan, 1989 - Bangladesh army personnel from 31 EBR, Khagrachari Zone, 31 EBR from Bet Chari Camp, 1st EBR from Bizitala Camp and also from Alutilla and Matiranga Camp, jointly carried out an operation against the Jumma village - Dhalya, Toiktang Mouza. During the operation, innocent Jumma inhabitants were subjected inhuman tortures and beating. As a result, 27 Chakma and Tripura families were compelled to abandon their ancestral village and are now living in total uncertainty. The victims are -

14. Mr. Parikshit Chakma, 40 yrs, son of Mr. Abhimanya Chakma, of Dhalya, Toikatang Mouza, Matiranga, P.S. Matiranga. He was beaten on a false allegation of giving food to the Shanti Bahini. The army personnel tied him with a rope and subjected him with severe beating.

15. Mr. Abhimanya Chakma, 60 yrs, of Dhalya, Toikatang Mouza, Matiranga P.S. He was beaten inhumanly with bamboo sticks and wooden block.

16. Mr. Nutan Jiban Chakma, 61 yrs, son of Mr. Buddha Moni Chakma, of Dhalya, Toikatang Mouza, Matiranga, P.S. Matiranga. During the operation he was caught by the army personnel. He was subjected to inhuman beating and tortures during interrogation. He was hit with a rifle butt and kicked to the ground and was asked if he possessed illegal gun.

17. Mr. Bira Shanka Chakma, alias Barpeda, 55 yrs, son of Mr. Rangachan Chakma, address -do-. He was kicked to the ground and was asked where the Karbari (village Head) of the village had gone. As he could not tell them, he was kicked inhumanly by the army personnel.

18. Mr. Suniti Ranjan Chakma, 45 yrs, son of Mr. Bengya Moni Chakma, address -do-. He was severely beaten when he said that there was no presence of Shanti Bahini members in the village when the army personnel charged him with an allegation that Shanti Bahini members came to the village yesterday.

19. Mr. Jhakya Chakma, 20 yrs, son of Mr. Kali Mohan Chakma, address -do-. He was subjected to severe beating as he was unable to give information about the Shanti Bahini during interrogation by the army personnel.

20. Mr. Chandra Dhar Chakma, 70 yrs, of Nania Char, P.S. Nania Char, was a guest of Mr. Suniti Ranjan Chakma. He was also beaten severely by the army personnel.

21. Mr. Suniti Chakma, 21 yrs, of Dhalya, Toikatang Mouza, P.S. Matiranga. He was subjected to severe beating with a false allegation by the army personnel that he gave shelter to the Shanti Bahini. He was taken at the army camp where he was tortured inhumanly and later he was given release.

22. Miss Shanti Rani Chakma, 20 yrs, daughter of Mr. Kamal Charan Chakma, address -do-. She was molested and severely beaten with rifle butts by the army personnel.

23. Mr. Sonadhan Tripura, 37 yrs, address -do-. He was falsely charged by the army personnel with an allegation that he gave information to the Shanti Bahini about the army personnel. He was beaten severely by the army personnel.

10 Jan. 1989 - A combing operation was carried out by Lt. Jamal and soldiers of 6 EBR, from the army camp at DP Para, P.S. Dighinala, against the Jumma inhabitants of Baghai Chari, Udal Bagan, Baghai Chari Mukh and South Babuchara under Dighinala P.S. During the operation, many innocent Jumma men and women were subjected to inhuman beating and tortures. The victims are -

11 Jan. 1989 - Capt. Aleem of 31 EBR, Bangladesh army, from army camp at Kuki Chara, P.S. Khagrachari, ordered 3 innocent Jumma persons to report at the army camp. Accordingly they reported and the Captain accused them of having contacts with the Shanti Bahini and giving food to them. The innocent persons were subjected to inhuman physical torture. The victims are -

The raid was carried out at 8.30 PM. During the raid, house to house searches were carried out and innocent inhabitants were arrested, beaten and were taken across the river Chengi. The arrested persons were subjected to interrogation and kept on the bridge over the river Chengi for the whole night in shivering cold. Next day, they were taken to the Zonal HQ at Khagrachari where they were again subjected to torture and interrogation after which they were given release. The victims are

05 Aug. 1988 - Major Badrul Huda of 1st East Bengal Regiment, Bangladesh army, Khyanghat camp, P.S. Mahal Chari and the Armed Police Battalion (APB) from the camp at Jantranath Karbari Para, Pagajya Chari, P.S. Mahal Chari, raided the Jumma villages, West Khyanghat Para and Jantra Nath Karbari Para, P.S. Mahal Chari, on pretext of operations against the Shanti Bahini. Innocent inhabitants were arrested and taken to the army camp where they were subjected to inhuman tortures during interrogation. The victims are -

1. Mr. Tutia Chakma, 50 yrs, son of Mr. Kamal Chakma, of West Khyanghat Para, No. 244 Limu Chari Mouza, P.S. Mahal Chari. Four bullocks were killed due to army firing.
2. Mr. Bana Bihari Chakma, address -do-. He was taken to Khyanghat camp and subjected to tortures during interrogation.
3. Mr. Bimal Chandra Chakma, a teacher, address -do-. As above.
4. Mr. Babu Lal Chakma, of Jantranath Karbari Para, Pagajya Chari, P.S. Mahal Chari. As above.
5. Mr. Arya Mitra Chakma, address -do-. As above.

06 Sept. 1988 - Two Jumma persons were arrested by the intelligence personnel of the Bangladesh army. The arrested persons were taken to the 1st EBR, Bangladesh army, Mahal Chari Zone. They were subjected to physical torture. The victims are -

6. Mr. Matilal Chakma, 30 yrs, son of Mr. Kali Mohan Chakma, of Tabalchari, Khyanghat, No. 249 Kyanghat Mouza, P.S. Mahal Chari. He was going to visit his father-in-law and carrying 4 fowls for his father-in-law. The perpetrators looted away the fowls. He was given release on 8 September, 1988 after tortures for two days.
7. Mr. Pralay Kishta Chakma, 30 yrs, a surrendered Shanti Bahini, son of Mr. Bijoy Bihari Chakma, address -do-. He was also arrested along with Mr. Motilal Chakma and tortured.

13 Sept. 1988 - An innocent Jumma person was arrested at Mahal Chari Bazar by intelligence personnel of the Bangladesh army on a false allegation of being a member of the Shanti Bahini. He was taken at the HQ of 1st EBR, Mahal Chari Zone, where he is being detained. The victim is -

8. Mr. Prabhat Chandra Chakma, 47 yrs, son of Mr. Ranga Uda Chakma, of Ulta Chari Mukh Adam, No. 249 Kyanghat Mouza, P.S. Mahal Chari.

14 Sept. 1988 - Two innocent persons were arrested in the farm house of Mr. Tatra Mohan Chakma in Kyanghat in the early hours of the morning by the army personnel from Kyanghat camp, P.S. Mahal Chari. They were taken to the army for interrogation and tortures. The victims are -

9. Mr. Kanungo Chakma, 38 yrs, son of Mr. Chandra Mohan Chakma, of Rangapani Chara, No. 3 Langadu Mouza, P.S. Langadu.
10. Mr. Bira Sen Chakma, 60 yrs, son of Mr. Sadhan Mani Chakma, address -do-.

21 Dec. 1988 - Bangladesh army personnel of 41 EBR, during operations against the Jumma inhabitants of Kuki Chara, No. 157 Choto Harina Mouza, P.S. Barkal, shot dead an innocent Jumma person and tortured another. The victims are -

11. Mr. Sneha Kumar Chakma, 32 yrs, son of Mr. Babunya Chakma, of Kuki Chara, No. 157 Choto Harina Mouza, P.S. Barkal. He was shot dead with submachine guns by the army personnel.
12. Mr. Kripa Dhan Chakma, 62 yrs, son of Mr. Jharbuadhan Chakma, address -do-. He was beaten inhumanly by the army personnel.

22 Dec. 1988 - Bangladesh army personnel of 41 EBR, carried out operations against the Jumma inhabitants of Bhalukya Chari, No. 158 Moudang Mouza, P.S. Barkal. During the operation, the army personnel resorted to looting, beating and rape. The victims are -

13. Mr. Mittang Chakma, 30 yrs, son of Mr. Areiya Chakma, of Bhalukya Chari, No. 158 Moudang Mouza, P.S. Barkal. He was beaten severely and Tk. 1500/- was looted away from him.
14. Mr. Laxmi Ranjan Chakma, 25 yrs, son of Mr. Battikhula Chakma, address -do-. Severely beaten and Tk. 1000/- was looted away from him.
15. Mr. Jnana Ranjan Chakma, 18 yrs, son of Mr. Battikhula Chakma, address

16. Mr. Shanti Shil Chakma, 26 yrs, son of Mr. Majan Bap Chakma, of South Sarbuatali, No. 384 Sarbuatali Mouza. Beaten as above.
17. Mr. Bidya Sagar Chakma, 19 yrs, son of Mr. Satish Chandra Chakma, of Bhalukya Chari, No. 158 Maudang Mouza, P.S. Barkal. As above.
18. Mr. Dinaram Chakma, 28 yrs, son of Mr. Krishna Paksha Chakma, address -do-. As above.
19. Mr. Gopal Chakma, 14 yrs, son of Mr. Mittang Chakma, address -do-. As above.
20. Mr. Dhana Chakma, 16 yrs, son of Mr. Krishna Paksha Chakma, address -do-. As above.
21. Mr. Punang Chan Chakma, 23 yrs, son of Mr. Areiya Chakma, address -do-. Beaten severely and Tk. 2650/- was looted away from him.
22. Mrs. Langhu Chakma, 20 yrs, wife of Mr. Punang Chan Chakma, address -do-. She was subjected to rape and Tk. 2000/- was looted away from her.
23. Mr. Cizibua Chakma, 5 months, son of Mr. Punang Chan Chakma, was thrown away from the lap of his mother by the perpetrators who raped her.
- 23 Dec. 1989 - Bangladesh army personnel of 41 EBR, from Kuki Chara Camp, during operation against the Jumma inhabitants of Kuki Chara, No. 157 Choto Harina Mouza, P.S. Barkal, resorted to looting, arsoning and beating. The victims are -
24. Mr. Lurangya Chakma, 48 yrs, son of Mr. Lal Chan Chakma, of Kuki Chara, No. 157 Choto Harina Mouza, P.S. Barkal. He was beaten and his house was burnt to ashes. The following properties were looted from him - Paddy - 40 quintals, rape seeds - 4 quintals, ginger - 5 quintals, 1 bullock and all the house-hold properties.
25. Mr. Jnana Kumar Chakma, 36 yrs, son of Mr. Dhada Chakma, address -do-. He was severely beaten, his house was set on fire after looting away the following properties - Paddy - 30 quintals, rape seeds - 3 quintals, rice - 1 quintal and all other house-hold properties.
26. Mr. Biraj Kumar Chakma, 25 yrs, son of Mr. Lurangya Chakma, address -do-. He was beaten and his house was set on fire after looting away the following properties - Paddy - 19 quintals, rape seeds - 2 quintals, rice - 80 kilos and all other house-hold properties.
27. Mr. Parandhan Chakma, 28 yrs, son of Mr. Sundarakha Chakma, address -do-. His house was burnt to ashes and the following properties were looted away from him - Paddy - 18 quintals, rape seeds - 3 quintals, Kapok - 2 quintals and all the house-hold properties.
28. Mr. Akshay Dhan Chakma, 45 yrs, son of Mr. Sundarakha Chakma, address -do-. His house was set on fire after looting away the following properties - Paddy - 41 quintals, rape seeds - 3 quintals, cotton - 1 quintal and all the house-hold properties.
29. Mr. Sharanya Chakma, 58 yrs, son of Mr. Lal Chan Chakma, address -do-. His house was set on fire after looting the following properties - paddy - 10 quintals and other house-hold properties.
30. Mr. Nalanya Chakma, 59 yrs, son of Mr. Dhananjay Chakma, address -do-. His house was set on fire after looting 25 quintals of paddy and all the other house-hold properties.
