MURDER & RAPE COMMITTED ON THE JUMMA PEOPLE OF
CHITTAGONG HILL TRACTS BY BANGLADESH ARMY,
PARA-MILITARY FORCES & BENGALI MUSLIM
INFILTRATORS

(MARCH, 1988 - DEC. 1988)

26 MARCH 1988 -

Lt. Col. Abdul Khaleque of I4 EBR, Bangladesh army, Zone Commander - Langudu Zone, Mainee Mukh, in a conspiracy with Abdur Rashid Sarkar (an infiltrator and illegally elected chairman of Langudu Upazilla) arrested the following innocent Jumma persons at Mainee Mukh Bazar. The victims were subjected to inhuman tortures immediately after arrest. They were taken to the army camp where they are being kept in detention since then. The victims are -

A Jumma girl student was raped by a BDR (Bangladesh Rifles) personnel of Dhuduk Chara BDR camp, Logang, P.S. Panchari. The victim is -

A communal riot took place when Bengali Muslim infiltrators tried to occupy the paddy land of the Jumma people at Batya Para,

No.3 Langudu Mouza, P.S. Langudu. The Jumma cultivators were busy cultivating their own lands, suddenly Bengali Muslim infiltrators attacked the Jumma people, saying loudly that they have come to CHT (Chittagong Hill Tracts) for land. The infiltrators attacked the Jumma persons with sharp deadly weapons, as a result, four Jumma persons were seriously wounded. They had to be taken to Langudu hospital for treatment. The victims are -

Two innocent Jumma persons were arrested by Bangladesh army personnel of Rangi Para camp, P.S. Langudu, in collusion with Bengali Muslim infiltrators. The arrested persons were taken at the army camp at Mainee Mukh for interrogation and tortures, then they were sent to DGFI (Directorate General of Forces' Intelligence) Unit at Rangamati for further interrogation. Later, charges were brought against the two as being Shanti Bahini associates. The victims are -

12. Mr. Kamini Ranjan Chakma, 18yrs, son of Mr. Brisha Ketu Chakma, of Lekyang Chara, No. 59 Banduk Bhanga Mouza, P.S. Kotwali. He was arrested on 8 APRIL 1988 and was taken at the army camp where he was subjected to physical tortures with his face covered with a piece of cloth and water poured on the face. He was hung upside down and beaten inhumanly. He was blind-folded and thrown into a dark pit and kept in detention for 22 days.
13. Mr. Biraj Kumar Chakma, 38yrs, son of Mr. Manik Chandra Chakma, of Durkheiya, No. 59 Banduk Bhanga Mouza, P.S. Kotwali. He was arrested on 9 APRIL 1988. He was tortured and detained as above.
14. Mr. Chitra Bilash Chakma, 50yrs, son of Mr. Chikyadhan Chakma, of Tang Tulya Mukh, No. 59 Banduk Bhanga Mouza, P.S. Kotwali. He was going to Rangamati for marketing on 9 APRIL 1988 in a boat which was stopped by the army officers and their men. The victim was subjected to inhuman tortures with his mouth being hit with a rifle butt as a result bleeding occurred profusely.
15. Master Deba Chakma, 16yrs, son of Mr. Chitra Bilash Chakma, address -do-. The victim was subjected to severe beating and tortures along with his father as given above.

taken at the FIU Centre where they were blind-folded, hands and legs
were tied up and subjected to inhuman physical tortures.
Interrogation about Shanti Bahini and tortures continued for two day
days without any food. They are being kept under army custody.

01 JULY 1988 -

Lt. Shamim of 31 EBR, Bangladesh army, from Khagrachari, raided the Jumma village - Harinath Para which is adjacent to Khagrachari Town. In the raid, the army lieutenant and his men encircled the house of a Jumma person. The house owner, family members and guests were all in deep sleep when the the soldiers opened burst fires with automatic weapons at 0120 hrs. killing instantly the house owner and his old mother. A young girl of 14yrs. who was also wounded in the attack was barbarously gang raped and later shot dead by the army personnel. The soldiers then set the house on fire. The victims are -

51. Mr. Man Mohan Chakma, 33yrs, son of late Bhada Chakma, of Harinath Para, P.S. Khagrachari. He was killed by the army lieutenant and his men.
52. Mrs. Sura Mukhi Chakma, 60yrs, widow of late Bhada Chakma, address -do-. Killed as above.
53. Miss Barun Mala Chakma, 14yrs, daughter of Mr. Jalakkamani Chakma, address -do-. She was seriously wounded in the attack but the soldiers did not spare her from their beastly gang rape and later she was killed by the soldiers. It is an irony of fate that the victim's family belonged to Jalbanda Mukh, No.30 Bar Merung Mouza, P.S. Merung. They were evicted from their ancestral village by the Bengali Muslim infiltrators in 1986.
54. Mrs. Mandadhari Chakma, 29yrs, wife of Mr. Lalit Kumar Chakma, of Rangapani Chara, No.262 Golabari Mouza, P.S. Khagrachari. She is sister of Mr. Man Mohan Chakma (Killed) and came to visit her brother and aged mother. She was also wounded by the army firing when a bullet hit her thumb. She was also gang raped by the soldiers.
55. Mila Chabua Chakma, 9 months, daughter of Mr. Lalit Kumar Chakma, address -do-. The little baby was also wounded by army firing. The baby and her mother had to go for treatment.
56. Mrs. Aduri Chakma, 19yrs, wife of deceased Man Mohan Chakma, of Harinath Para, P.S. Khagrachari, Although she was saved from the army bullets but she was a victim of gang rape by the army personnel in the attack. The soldiers snatched away her 1 1/2 yr old child who was thrown on the floor and the soldiers committed gang rape.

Bengali Muslim infiltrators in 1986. On the night of the army attack he was brought out of the house by the soldiers with kicks.

30 JULY 1988 -

Another gruesome massacre was carried out by Bengali Muslim infiltrators. The incident occurred when Mr. Rajani Kanta Chakma (a former member of Union Parishad) and eight other Jumma men, women and children were returning home from Mainee Mukh Bazar, P.S. Langudu, in a boat driven by an infiltrator named - Md. Khalil. The Muslim infiltrator, instead of taking them to their destination, took the passengers to the infiltrators settlement called - Bat Taja, situated on the west bank of Mainee river. As the boat reached the river bank, the Jumma passengers were attacked by Bengali Muslim infiltrators. When the victims did not return home, their relations immediately reported to the Police Station at Langudu. Further, it was also brought to the notice of the Camp Commander of the army camp at Korolya Chari, P.S. Langudu, with regard to the missing of nine Jumma persons and finding out the culprits. When no necessary action was taken on the incident, it was on 03 AUGUST 1988 during a meeting Tribal Convention arranged by army authorities at the Town Hall, Tintilla, where Col. Imamuzzaman, Commander of 305 Brigade, Rangamati, was the chief guest, the matter was brought before him. But Col. Imamuzzaman dismissed the complaint on the incident and remarked - " So far, many Muslims have been killed by the Shanti Bahini in different actions but the government has not reacted to these incidents but when a few Jumma people are killed why there is so much of reaction? " He said angrily, " In future, if a single Muslim is found missing or Killed, then for each Muslim 15 Jummas shall be shot dead by the army personnel. " Particulars of the victims -
