Sub: An appeal to save the Chakma and other tribes of the Chittagong Hill Tracts from the total annihilation by the Bangladesh Government.

Dear Brother.

May I present to you a report, "An account of further atrocities (murder, rape, looting, arsoning etc) and gross violations of Human Rights in the Chittagong Hill Tracts by Bangladesh Forces from January 1986 to July 1986", sent by the Jana Samhati Samiti, the only political party in the Chittagong Hill Tracts (CHT), on 25th September 1986.

The Bangladesh armed forces and the Bengali settlers have not only carried out Matiranga, Panchari, Khagrachari and Dighinala massacres but they have also committed countless genocidal and racial crimes everywhere in the region. This report has recorded 280 cases of gross human rights violations starting from rape to murder. Some of these diabolical activities of the Bangladeshi regime are listed below:

A. MURDER

- 1. On March 17, 1986, the Bangladesh army personnel (305th Brigade) of Fakirachara camp, raided the village of Muralyabap Chara, a concentration camp, in Subalong within Barkal Upazilla, tortured, raped and killed the residents. For example, (i) Miss Gurimala Chakma, 14, daughter of Mr. Harilal Chakma, and (ii) Miss Milaso Chakma, 15, daughter of Mr. Hangotya Chakma, were gang-raped and them shot dead by the Bengali soldiers.
- 2. In the first week of July 1986, the Bangladesh armymen of Hatimara camp and the Bengali settlers launched genocidal campaigns in ? villages in Mamik Chari Upazilla - Pota Chara, Sonkhola, Remna Adam, Riomorong, Dheppua, Fakira Nala and Dulu Adam -, in 3 villages in Laxmi Chari Upazilla - Laxmi Chari, Dulu Para and Kalapani -, and in Guimara village of Guimara Upazilla. They stole stocks, looted valuable things, burnt houses, desecrated and destroyed Buddhist temples, beat Buddhist monks, raped women, and tortured and murdered both men and women. For instance, on 2nd July 1986, (i) Mr. Maney Marma, 70, of Fakira Wala village in Halfchari Mouza, was hacked to death by the Bengali settlers. the same day, the Bengali settlers butchered Mr. Paichai Marma. 70. a shopkeeper of Hatimara Bazar, of Moradulu village.

On July 3, 1986, the Bengali settlers killed the following tribals: The women were raped and then murdered.

- i). Mrs. Aprumah Marma, 45, wife of Mr. Kala Aung Marma, of Laxmichari village.
- ii). Mrs. Mishu Prue Marma, 26, wife of Mr. Chathong Marma, of Dulu Para village.
- Miss Minu Prue Marma, 17, daughter of Mr. Kyo Hla Prue Marma, of iii). Dulu Para village.
- iv). Mr. Thoi Hla Aung Marma, 30, son of Mr. U Hla Prue Marma, of Kalapani village was beheaded.
- v). Mrs. U Chongmah Marma, 25, wife of Mr. Thoi Hla Aung Marma, of Kalapani village was also beheaded.
- vi). Mrs. Mrah Chain U Marma, 28, wife of Mr. Kyathuai Marma, of Kalapani village, was also beheaded.
- Mr. Hla Thuai Marma, 34, of Kalapani village. Mrs. Jyo Sa U Marma, 31, of Guimara village. vii).
- viii).
- Mrs. U Nu Prue Marma, 23, of Guimara village. ix).
- x). Mrs. Mah Aung Prue, 26, of Guimara.

- 3. On 12th July 1986, five Jummas were bringing rice from their relatives in Boradam village within Longudu Upazilla. On the way at a place in between Boiragi Bazar and Gulsakhali, the Bengali immigrants robbed them of their belongings and then murdered them. The victims were as follows:
- i). Mrs. Surya Bala Chakma, 35, daughter of Mr. Mukunda Lal Chakma, of Rangei Para village in Longudu Upazilla.
- ii). Mr. Sudhir Chandra Chakma, 45, son of Mr. Uttara Kanta Chakma, of Pedanyama Chara village in Longudu Upazilla.
- iii). Mr. Ram Chandra Chakma, 35, son of Mr. Khatya Chakma, of Guichari village in Longudu Upazilla.
- iv). Mr. Fanendra Chakma, 30, son of Mr. Tagara Chakma, of Guichari village in Longudu Upazilla.
- v). Master Bharat Mohan Chakma, 16, son of Mr. Tagara Chakma, of Guichari village in Longudu Upazilla.
- 4. On July 21, 1986, six Jumma men and a Jumma girl were returning home from the market. When they arrived at Shontilla at about 12.00 hrs, the Bengali infiltrators attacked and killed all Jumma men. Then the culprits gang-raped Miss Noromi Chakma, 14, daughter of Mr. Chandra Chakma, of Mangaldhon Karbari Para village in Panchari Upazilla. When she was going to be killed then a Bengali suggested that he wanted to marry her after converting her to Islam. He took her to his home but his wife helped Miss Noromi Chakma to flee to her home. She disclosed the incident to the villagers who in turn reported the matter to the Army Zonal Commander at Panchari. An Army Investigation Team was sent and the Jumma girl identified the culprits but no action was taken against the murderers. The names of the victims are shown below. They were all from Panchari Upazilla.
- i). Mr. Jatindra Chakma, 32, son of Mr. Monchan Chakma, of Jibanaswa Para village.
- ii). Mr. Monchan Chakma, 65, son of Mr. Sambhunath Chakma, of Jibanaswa Para village.
- iii). Mr. Amar Chakma, 40, son of Mr. Pokka Chakma, of Jibanaswa Para.
- iv). Mr. Manu Kumar Chakma, 38, son of Mr. Raj Kumar Chakma, of Jibanaswa Para village.
- v). Mr. Arun Kumar Chakma, 42, of Jibanaswa Para village.
- vi). Mr. Rajmoni Chakma, 62, son of Mr. Aradhon Karbari, of Jibanaswa Para village.
- 5. On July 30, 1986, the Bengali immigrants murdered Mr. Mrittunjoy Tripura, 32, son of Mr. Danta Ray Tripura, of Ghulchari village in Merung Upazilla, while he was returning home alone from the market.

B. RAPE

- 1. On January 24, 1986, the Bangladesh army men (7th East Bengal Regiment) of the Churakhali camp raided Ghilatoli village in Longudu Upazilla, tortured the innocent villagers and raped many women. For example, (i) Miss Anita Bala Chakma, 15, daughter of Mr. Madanya Chakma, and (ii) Miss Sonadevi Chakma, 14, daughter of Mr. Bhando Chakma, were gang-raped until they became unconscious and were bleeding profusely.
- 2. Army units from Naniachar, Kudukchari and Bogachari camps, led by 2/Lt. Hanif of the 40th East Bengal Regiment, launched oppressive campaigns in Maicchari and Krishnama Chara villages within Rangamati Upazilla from 27th February 1986 to 1st March. During these brutal operations, the Bengali soldiers raped hundreds of women including (i) Miss Sabita Rani Chakma, 12, daughter of Mr. Kalya Chakma, of Krishnama Chara village, and (ii) Miss Bubi Chakma, 12, daughter of Mr. Wakko Chakma, of Krishnama Chara village on 1st March 1986.
- 3. On May 10, 1986, an army contingent, under the command of Captain Khaleque of the 26th East Bengal Regiment from Barabunnya camp made attacks on the villagers of Harin Ghat Chara, Nava Karbari Para and Pata Chari in Naniachar Upazilla and opened fire indiscriminately on

them with machine guns. At that time, Miss Kajola Devi Chakma, 17, daughter of Mr. Kshetra Bihari Chakma, of Harin Ghat Chara, was inside the house and she was hit by bullets. Although she was in great pain, the Bengali armymen took her to the Primary School at Jaduga Chara village in Naniachar Upazilla and gang-raped her. Then they put a bamboo pipe into her private parts. As a result of such beastly torture she died.

Similarly, (i) Miss Dhelly Chakma, 15, daughter of Mr. Nanda Dulal Chakma, of Nava Karbari Para, (ii) Miss Padma Maya Chakma, 15, daughter of Mr. Kisto Dayal Chakma, of Nava Karbari Para, (iii) Miss Neeladevi Chakma, 15, daughter of Mr. Tarulal Chakma, of Patachari village, (iv) Miss Lipika Chakma, 15, daughter of Mr. Ananda Kumar Chakma, of Harin Ghat Para, and many others were gang-raped by the members of the Bangladesh army.

- 4. On July 7, 1986, some Bengali settlers of Betchari Mukh village in Khagrachari Upazilla, set fire to their own houses and then reported to the Betchari Mukh army camp that the members of the Shanti Bahini had burnt their dwellings. On receiving this report, Major Sharif, Subedar Akhtar and their troops (30th East Bengal Regiment) attacked the innocent tribal people at Betchari Mukh and unleashed a reign of terror in the area. The Jumma people were beaten, tortured and the women were raped. For instance, Miss Chibachogi Chakma, 14, daughter of Mr. Kalo Chakma, was raped by the Bengali invaders.
- on 20th July 1986, two Village Defence Party (Bengali settlers trained in the use of light arms) personnel Abdul Khaleque and Syedul assaulted Miss Gopadevi Chakma, 15, daughter of Mr. Krishna Laxman Chakma, of Deno-Atarakchara village in Longudu Upazilla, while she was working in a paddy field. They tied her hands, put a handkerchief into her mouth, and then raped her.

C. TORTURE

- 1. On January 24, 1986, the members of the Bangladesh Army (7th East Bengal Regiment) raided the house of Mr. Monoranjan Chakma, 30, son of Mr. Madanya Chakma, of Ghilatoli village in Longudu Upazilla, and tortured him brutally. He was beaten severely and he fainted three times when his testicles were squeezed during the torture.
- 2. On February 18, 1986, Lt. Ahmed Sharif and his soldiers (26th East Bengal Regiment) of Barana Chari army camp, invaded the house of Mr. Marattua Chakma, 19, son of Mr. Nalindra Chakma, of Petyachari village in Longudu Upazilla, and subjected him to inhuman torture. He fainted three times when the Bengali officer gave him electric shocks on his penis and ears.
- On 5th March 1986, the soldiers of the army camp at Dhupsil near Kaptai, raided Golachari village in Rangamati Upazilla, and tortured brutally (i) Mr. Sundarmoni Dewan, 19, son of Mr. Isan Chandra Dewan and (ii) Mr. Vira Tongchongya, 20, son of Mr. Goreiya Tongchongya. These two victims were given electric shocks and water was forced through their mouths and noses.
- 4. On May 10, 1986, an army contingent led by Captain Khaleque (26th East Bengal Regiment) from the camp at Barabunnya, turtured many Jummas of Nava Karbari Para village in Naniachar Upazilla. One of them was Mr. Juron Chandra Chakma, 25, son of Mr. Kalikinkar Chakma. He was hung upside down and water mixed with chilli powder was force into his mouth and nose.

D. DETENTION WITHOUT CHARGE OR TRIAL

1. On April 8, 1986, Mr. Vinod Ranjan Chakma, 40, son of Mr. Dilip Kumar Chakma, of Jogonatuli village in Naniachar Upazilla, was ordered to report to an army camp. On his arrival at the Naniachar army camp, he was arrested on suspicion as a member of the Shanti Bahini and sent to the army camp at Barpul Para for interrogation

and torturing. Thereafter, he was taken to Thalchara army camp where he was further interrogated and tortured. Then he was sent to the Zonal Head Quarters at Barabunnya. There he is being kept without charge or trial.

- 2. On April 14, 1986, Mr. Betra Chakma, 25, son of Mr. Aush Chandra Chakma, of Chekko Para in Naniachar Upazilla, was arrested by the soldiers of the 26th East Bengal Regiment (EBR) from Barapul Para army camp. After interrogation and torturing, he was also sent to the Zonal Head Quarters at Barabunnya where he is being held without charge and trial.
- 3. On June 29, 1986, the Bangladesh armymen of Naniachar camp, asked many local Jumma citizens to attend a meeting at Kattaltali Primary School. After the meeting was over, six Jumma gentlemen were taken to the army camp. Among them were (i) Mr. Amar Kanti Dewan, 35, son of Mr. Sahasra Dewan, of Kattaltali village, and (ii) Mr. Nirmalendu Khisa, 40, son of Mr. Indra Ranjan Khisa, of Kattaltali village in Naniachar Upazilla. They were tortured inhumanly during interrogation. Later both of them were sent to Rangamati for further interrogation and torturing by the Directorate General of Forces intelligence (DGFI). The military authorities refused to give any information about them to their relatives.
- On 11th July 1986, the members of the Bangladesh army (7th East 4. Bengal Regiment) of Korolya Chari camp, under the command of Capt. Khatem Ali, attacked two villages - Deno-Atarak Chara and Korolya Chari - in Longudu Upazilla. They shelled the villages with 60 mm mortars and opened fire on the villages with machine guns. Then they rounded up the villagers and subjected them to inhuman torture. The invaders took the following villagers to the army camp and they have not been released yet. (i) Mr. Nalini Mohan Chakma, a Member of Union Council, son of Mr. Rizav Karbari, of Deno-Atarak Chara, (ii) Mr. Rajmohan Chakma, son of Mr. Rizav Karbari, of Deno-Atarak Chara, (iii) Mr. Rajani Kanta Chakma, son of Mr. Sampurna Chakma, of Korolya Chari, (iv) Mr. Ranga Uda Chakma, son of Mr. Succhyangya Chakma, of Korolya Chari, (v) Mr. Kripa Mohan Chakma, (vi) Mr. Chikko Kumar Chakma, son of Mr. Manik Chandra Karbari, of Deno-Atarak Chara, (vii) Mr. Bhutto Kumar Chakma, son of Mr. Manik Chandra Karbari, of Deno-Atarak Chara, (viii) Mr. Kandu Chakma, son of Mr. Bashimohan Chakma, of Deno-Atarak Chara, (ix) Mr. Manik Chandra Karbari, of Deno-Atarak Chara, and (x) Mr. Kamini Chandra Chakma, of Deno-Atarak Chara.
- on June 24, 1986, (i) Mr. Tokkhula Chakma, son of Mr. Ananda Chakma, of no. 3 Rubber Plantation in Lamba Chara, (ii) Mr. Monoranjan Chakma, of no. 1 Rubber Plantation in Ghulchari, and (iii) Mr. Nalini Chakma, son of Mr. Dubramoni Chakma, of Ghulchari, were arrested by the army personnel when they came to collect their pigs from their native village which they had to leave due to the oppression committed by the Bangladesh armed forces and the Bengali settlers. These Jummas have been detained in the army camp without charge or trial. Their fates still are not known.

E. EXTORTION AND ROBBERY

- 1. On May 7, 1986, an army unit (26th East Bengal Regiment) of Barpul Para camp, attacked the villagers of Bakchari Thoom Adam in Naniachar Upazilla, for boycotting the May 7, 1986, General Election in Bangla Desh. These invading oppressors beat the Jummas en masse severely and stole all their valuables such as ornaments, money, rice, fowls, goats and cattle worth Taka 60,000/-. (i) Mr. Gogon Chandra Chakma, son of Mr. Kalashesh Chakma, (ii) Mr. Raj Chandra Chakma, 30, son of Mr. Jurodhan Chakma, (iii) Mr. Sadhan Chandra Chakma, 40, son of Mr. Rangashesh Chakma, and many other villagers were robbed of their belongings by the Bangladesh army.
- 2. On June 12, 1986, Lt. Kabir (41st East Bengal Regiment) of Marishya page 5/-

army camp, arrested without warrant (i) Mr. Ajit Kumar Chakma, 18, son of Mr. Chiroshanti Chakma, of Ugalchari village in Baghaichari Upazilla, and (ii) Mr. Bimalendu Chakma, 25, son of Mr. Rajani Chakma, of Lalyaghona village in Baghaichari Upazilla, and subjected them to inhuman torture in the army camp. In addition to routine torture, the first victim was given electric shocks on his genitals. The second victim was kicked in the face, water was forced into his mouth and nose, and his testicles were squeezed. As a result of such beastly torture, he lost consciousness three times during the interrogation. The Bengali officer released them on 13th June 1986 only after extorting Taka 10.000/- from them.

- on June 29, 1986, the army authorities of Naniachar camp, ordered the local Jumma leaders to assemble at Kattaltali Primary School. In the meeting, the military commanders criticised bitterly the Jumma people's movement for self-determination and warned the Jumma people not to support the Shanti Bahini. At the end of the meeting, the military men arrested six innocent Jumma participants and took them to the army camp for interrogation and torturing. (i) Mr. Mukunda Lal Chakma, 55, son of Mr. Kalikinkar Chakma, of Bhangamura village in Naniachar Upazilla, and (ii) Mr. Smritimoy Dewan, 45, son of late Madhav Chandra Dewan, of Kattaltali village in Naniachar Upazilla were among the captives. Mr. Chakma and Mr. Dewan were released only after payment of Taka 10,000/- and Taka 12,000/- respectively to the army authorities.
- 4. On July 11, 1986, the Bengali settlers raided the house of Mr. Kamala Kanti Chakma, son of Mr. Binanda Rakhal Chakma, of Ghulchari village in Betchari area within Merung Upazilla. They robbed him of all valuable things gold and silver ornaments, rice, goats, cattle, fowls and so on amounting to Taka 50,000/-.

F. RELIGIOUS PERSECUTION

- 1. On February 6, 1986, Lt. Juglul of the Bangladesh army (13th East Bengal Regiment, Silban camp) arrested (i) Mr. Kala Uda Chakma, 35, son of Mr. Tarani Chakma, of Dewano Chara in Mahalchari Upazilla, and (ii) Mr. Sudhir Chandra Chakma, 36, a Member of Union Council, son of Mr. Tambru Dhawj Chakma, of Madhya Adam village in Mahalchari Upazilla, and took them to the Madhya Adam Buddhist Vihara (temple). There they were tortured, hung upside down, and water was forced in to their mouths and noses.
- 2. On 16th March 1986, Major Mustafizur Rahman of the Bangladesh army (26th East Bengal Regiment, Barabunnya Zone) rounded up Mr. Ananda Chakma, 45, son of Mr. Hela Bujjya Chakma, of Barkalak village in Longudu Upazilla, and took him to the Tunyachari Buddhist Vihara (temple) and tortured him inhumanly in order to force him to confess that he had contact with the Shanti Bahini. This army officer desecrated the temple and said to the monks and Jummas "(The) Britishers couldn't make these Kafirs (non-believers) accept Christianity but we are going to force them to embrace Islam".
- Regiment, Bangladesh army), Major Khairul Alam (14th Battalion of the Bangladesh Rifles in Marishya), Humayun Kabir (Adjutant of the Village Defence Party), Hasan Ali (Village Defence Party Commander), Amirul Karim (Upazilla Nirbahi Officer), and Haider Ali (a resident near Baghaichari Upazilla Office), organised communal riots in Lalyaghona, Ugalchari, Tulaban and Jibanga Chara areas of Baghaichari Upazilla on May 8, 1986.

The Bengali settlers who carried out the violence were led by (i) Shamsul Huda, Chairman of Rupakari Union Parishad (Council), a resident of Battali in Baghaichari Upazilla, (ii) Azizur Rahman, a contractor, a resident of Jibanga Chara in Baghaichari Upazilla, (iii) Hafiz Mohammad Majhee of Kasalong Bazar in Baghaichari Upazilla, (iv) Asghar Ali of Ugalchari in Baghaichari Upazilla, (v) Sukkar of

Ugalchari in Baghaichari Upazilla, and other Bengali leaders.

Under the guidance of the Bangladesh armed forces, the Bengali immigrants attacked the tribal villages, looted stocks and all valuable articles, burnt houses, raped the tribal women, tortured the Jumma people, desecrated the Buddhist temples and tortured the Buddhist monks. The Navajyoti Buddhist Vihara (temple) in the Lalyaghona village, for instance, was plundered and desecrated. The invaders kicked and broke all the four images of the Buddha in the temple including the one brought from Thailand. They beat the Director of the temple, Rev. Prajna Sara Bhikkhu, so severely that he fell unconscious. He was also not allowed to take food and water.

4. On 2nd July 1986, the members of the Bangladesh army from Hatimara camp and the Bengali settlers raided the house of Mr. Thoi Aung Prue Marma, 72, son of Mr. Chai O Hra Marma, of Fakira Nala in Hafchari Mouza within Manikchari Upazilla, stole 50 quintals of rice, and set his house and Buddhist temple on fire.

G. THE PLIGHT OF JUMMA REFUGEES AFTER DEPORTATION FROM MIZORAM

As a result of massacres in the Bhusan Chara area in May 1984, over 4,000 Jumma refugees took shelter at Tibira Ghat and Tagalak Bag in the State of Mizoram of India. On 1st January 1986, they were handed over, against their will, to the members of the Bangla Desh Rifles (BDR). The BDR men put them in motor launches and divided them into two groups - all men in the upper deck and all women and children on the lower deck. Then a military commander told the refugees - "You dirty Kafirs (non-believers), there is nobody in the world who can save you now from us. Why did you go to bloody India? Do you think bloody India can save you right now?". After he finished his speech, the Bengali soldiers attacked the refugees. They stripped clothes from all women and girls and gang-raped them. The male refugees were beaten and tortured. It is, perhaps, worth noting that the refugees were not rehabilitated because their ancestral villages and farmlands had already been appropriated by the Bengali settlers. Their fates are not known.

The Bangladesh armed forces and the Bengali settlers are exterminating the Jumma people systematically because they want the land and mot the indigenous people of the CHT. This pogrom will continue unabated until the international community intervenes in the region and compels the Bangladeshi regime to implement the following measures:

Removal of all Bengali settlers from the CHT.

2. Withdrawal of all Bangladesh armed forces including the non-tribal police force from the CHT.

3. Retention of the Chittagong Hill Tracts Regulation of 1900 and constitutional provision restricting the amendment of the Regulation.

4. Autonomy for the CHT with its own legislature and recognition of the Jumma people's right to self-determination.

5. Deployment of the UN Peace Keeping Force in the CHT and implementation of this programme under the auspices of the UNO.

The Jumma people are as helpless as children in the face of the fundamentally hostile Bengali invasion. They will not survive without your help. I appeal fervently to you to take all necessary actions in order to liberate the Jumma people from the racial and genocidal tyrannies of the Bangladeshi regime. With my best regards.

AN ACCOUNT OF FURTHER ATROCITIES (MURDER, RAPE, LOOTING, ARSONING, ETC.) AND GROSS VIOLATIONS OF HUMAN RIGHTS IN THE CHITTAGONG HILL TRACTS BY BANGLADESH FORCES FROM JANUARY, 1986 TO JULY, 1986.

On January1, 1986 when the Chakma refugees, who took refuge in Mizoram of India to escape brutal massacres and rape committed by Bangladesh army, BDR (Bangladesh Rifles) and illegal Bengalee muslim infiltrators in Gorosthan and Bhusan Chara in May, 1984, were pushed back and handed over to the BDR against their will, women refugees were barbarously raped by the BUR personnels in the motor launch in which the refugees were being brought for unknown destination of concentration camps. Most barbarous and uncivilised ill treatment meted out to the Chakma refugees in the motor launch was men and women were separated into two groups. Male refugees were taken to the upper deck so that they would not be able to give any resistance to the EDR personnels while molesting the women refugees who were kept in the lower deck. The BDR personnels at gun point undressed all the women refugees despite their utmost resistance and cries for help and to spare them from such beastly treatment. One of the BDR personnels then said to these panic stricken women refugees "You dirty kafirs, there is nobody in the world who could save you now from us. why did you go to bloody India? Do you think bloody India can save you right now?" With these words the BDR personnels swooped upon the helpless women and girls molesting every one. The following girls and women were taken to the upper deck, forced into a cabin and gang raped:

- Niralata Chakma, 25yrs, wife of Karuna Mohan Chakma of Gorosthan, P.S. (Police Station) Barkal.
- 2. Lakshmi Mita Chakma, 17yrs, D/O. Patyaram Chakma, address -do-.
- 3. Suranga Devi Chakma, 18yrs, D/O. Rajani Mohan Chakma, address -do-.
- 4. Virasashi Chakma, 24yrs, wife of Suresh Kumar Chakma of Bhusan Chara, P.S. Barkal.

On January 24, 1986 soldiers of 7th EBR(East Bengal Regiment), Bangladesh army, Churakhali camp, raided the Chakma village of Ghilatoli, P.S. Longudu, committing rape and tortures on the innocent inhabitants. Names of the victims and their addresses are given below:

5. Manoranjan Chakma, 30 yrs, S/O. Madanya Chakma, of Ghilatoli, P.S. Longudu, was rounded up in his house on a false pretext of searching for illegal arms. He was beaten severely and he fainted four times when his testicles were squeezed by the soldiers during interrogation.

- 6. Anita Bala Chakma, 15yrs, D/G. Madanya Chakma, of Ghilatoli, P.S. Longudu, was raped in her house consecutively by the soldiers who left her in bleeding condition.
- 7. Sonadevi Chakma, 14yrs, D/O. Bhando Chakma, address -do-, was also raped by the soldiers in her house till she became unconscious. She was bleeding profusely when the soldiers left her.
- 8. On February 2, 1986 an army unit of Maram Chari Mukh army camp, Bormachari, led by Subedar Sikandar during its operations in the village ordered Khudi Aung Marma,45yrs, S/O. Hnara Aung Marma of Maram Chari Mukh, P.S. Laxmichari, to supply them a bullock for a sumptuous meal and it was immediately complied with. When Khudi Aung requested the army Subedar to pay the price of the bullock, the Subedar kicked him to the ground and ordered his soldiers to give him a good beating. The victim was beaten severely and tortured inhumanly. He was hung upside down and water was forced in his nose and mouth.
- 9. On February 4, 1986 Aungshei Headman, S/O. Hla Brey Marma, of Maram Chari Mukh, P.S. Laxmichari, was also beaten by the above Subedar of Maram Chari Mukh army camp, when he pleaded to the Subedar to pay the price of the bullock to Khudi Aung Marma.

On February 6, 1986 Lt. Juglul of 13th EBR, Bangladesh army, Silban camp, arrested two persons from Madhya Adam and Dewand Chara, P.S. Mohalchari, for their support to the Jana Samhati Samiti(JSS). The arrested persons were taken to the Buddhist Vihara of Madhya Adam where they were tortured by the Lieutenant who oredered his soldiers to hang them upside down and pour water in their mouths and noses. Below the names of the victims are mentioned:

- 10. Kala Uda Chakma, 35yrs, S/O. Tarani Chakma, of Dewano Chara, P.S. Mohalchari.
- 11. Sudhir Chandra Member, 36yrs, S/O. Tambru Dhawj Chakma, of Madhya Adam, P.S. -do-.

On February 15, 1986 Lt. Ahmed Sharif of 26th EBR, Bangladesh army, Barana Chari army camp, Barabunnya Zone, raided the Chakma villages committing tortures, rape and beating the innocent inhabitants. Names of the victims are given below:

- 12. Surama Devi Chakma, 28yrs, wife of Anilya Chakma, of Petyachari, P.S. Longudu, was brutally raped by the soldiers who left her in bleeding condition.
- 13. Kalabi Chakma, 45yrs, wife of Ramani Mohan Chakma, of Silcharî, P.S. Longudu, was physically tortured for refusing to give fowls free of cost to the soldiers.
- 14. Chandra Gandha Chakma, 47yrs, wife of Nalindra Chakma, of Tunyachari, P.S. Longudu, was beaten severely for being unable to give informations about the Shanti Bahini.
- 15. Ajolata Chakma, 21 yrs, wife of Nuachan Chakma, of Silchari, P.S. -do-, was physically tortured and raped infront of her husband.

Bangladesh army, Barana Chari camp, Barabunnya Zone, raided the Chakma villages - Tunyachari and Petyachari committing rape and tortures on the innocent inhabitants. Names of the victims are furnished below:

- 16. Medoli Chakma, 22yrs, wife of Kinamoni Chakma, of Petyachari, P.S. Longudu, was gang raped in her house by the soldiers of Lt. Ahmed Sharif.
- 17. Marattua Chakma, 19yrs, S/D. Nalindra Chakma, of Funyachari, P.S. -do-, was subjected to inhuman tortures for being unable to give informations about the Shanti Bahini. Lt. Ahmed Sharif personally conducted the interrogation and torturing. The victim fainted three times when Lt. Ahmed Sharif gave electric shocks on his penis and ears during interrogation.
- 18. Lalit Kumar Chakma, 55yrs, S/O. Dianya Chakma, of Petyachari, P.S. -do-, was beaten severely in his house for failing to give them informations about the JSS workers who are struggling for the right of Self-determination in the CHT.
 - Army units from Naniachar, Kudukchari and Bogachari camps jointly carried out military operations in the Chakma villages Maicchari and Krishnama Chara, P.S. Kotowali, from February 27, 1986 to March 1, 1986. Chakma women and girls including minor ones were raped barbarously during the operations led by 2/Lt. Hanif of 40th EBR, Bangladesh army. Names of the victims are mentioned below:
- 19. Minakshima Chakma, 35yrs, wife of Minakshibap Chakma, of Maicchari, P.S. Kotowali, was raped in her house by the soldiers of 40th EBR, Bangladesh army on February 28, 1986.
- 20. Kadampudi Chakma, 18yrs, D/O. Kalipada Chakma, address -do-, a student of High School, was gang raped in her house by the soldiers of 40th EBR on February 27, 1986.
- 21. On March 1, 1986 Sabita Rani Chakma, 12yrs, D/O. Kalya Chakma, of Krishnama Chara, P.S. -do-, was raped by the soldiers of 40th EBR.
- 22. On the same day, Bubi Chakma, 12yrs, D/O. Wakko Chakma, address -do-, was also raped by the soldiers of 40th EBR, Bangladesh army.

 On March 5, 1986 soldiers from the army camp at Dhupsil, Kaptai, raided the village Golachari, P.S. Kotowali, and rounded up two innocent persons on of being Shanti Bahini. The arrested persons were taken to the camp where they were subjected to inhuman tortures during interrogation. The persons are -
- 23. Sundarmoni Dewan, 19yrs, S/O. Isan Chandra Dewan, of Golachari, P.S. Kotowali, was tortured with electric shocks and had water poured through the nose and the mouth.
- 24. Vira Tongchongya, 20yrs, S/O. Goreiya Tongchongya, address -do-, was also tortured as above.

- 25. On March 11, 1986 Rajani Kanta Chakma, 35yrs, S/D. Rajendra Chakma, of Silchari, P.S. Longudu, was ordered to report at the Zonal Head Quarters by Lt. Col. Zillur Rehman, C.O. (Commanding Officer) of 26th EBR, Bangladesh army, Barabunnya Zone, for informations about the Shanti Bahini. As he could not give them any information about the Shanti Bahini camps and their hide outs, he was immediately taken into the interrogation room and flogged with a whip. After being released, he returned home with his white shirt stained with blood due to whipping. The incident created panic among the innocent inhabitants of the village.
- 26. On March 16, 1986 Ananda Chakma, 45yrs, S/O. Hola Bujjya, of Barkolok, P.S. Longudu, was rounded up in his house by Maj. Mustafizur Rehman of 26th EER, Bangladesh army, Barabunnya Zone. He was taken to Tunyachari Buddhist Vihara where he was interrogated and subjected to inhuman physical tortures for a confession in order to institute a criminal case against him as having communications with the Shanti Bahini. The army officer also desecrated the temple bavingt no respect for its religious sanctity by entering the temple without taking off his boots and carried a gun with him and an ill remark "Britishers couldn't make these Kafirs (Non-believers in Islam but the term is used by the Bengalee muslims to mean as inferior hated being) accept christianity but we are going to force them embrace Islam".
- 27. Bharat Varsa Chakma, 42yrs, S/O. Medera Chakma, address -do-, was also rounded up in his house and tortured by Maj. Mustafizur Rehman on the same day as above.
 - On March 17, 1986 soldiers from the army camp at Fakirachara, of 305 BDE (Brigade), surrounded the village of Muralyabap, P.S. Barkal, which has been made a part of concentration camp set up by the army. Bangladesh government has named these concentration camps as 'Ideal villages' to mislead the world opinion and make the inhabitants live a subhuman life who are always molested, harrassed and beaten under a pretext or without any reason by Bangladesh forces. Names of the victims are given below:
- 28. Gurimila Chakma, 14yrs, D/O. Harilal Chakma, of Muralyabap Chara, Subalong Concentration Camp area, P.S. Barkal, was gang raped by the army personnels and shot her to death after the barbarous raping.
- 29. Milaso Chakma, 15yrs, D/O. Hengotya Chakma, address -do-, was brutally raped and killed by the army personnels.
- 30. On March 20, 1986 army units of 26th EBR from Barabunnya Zone and Thalchara camp, rounded up Prakiti Ranjan Chakma, S/G. Gulchoga Chakma, of Jaduga Chara, P.S. Naniachar, at his residence. He was beaten severely till he fainted by the soldiers for his sympathy for the Jana Samhati Samiti.

He was taken to the Primary School of Jaduga Chara where he was interrogated, beaten and tortured by the soldiers for his support to the cause of Self-determination in the CHT.

- 32. On March 24, 1986 soldiers of 40th EBR, Bangladesh army, Naniachar Duk Bunglow camp, raided the house of Sama Ranjan Chakma, 60yrs, S/O. Subha Kanta Chakma, of Sonkhola Para, P.S. Naniachar. He was subjected to fortures during interrogation.
- 33. On April 8, 1986 Vinod Ranjan Chakma, 4Dyrs, S/O. Dilip Kumar Chakma, of Jogonatuli, P.S. Mohal Chari, was ordered to report at the army camp by Major Reham, 26th EBR, Thalchara camp. When he reported to the army camp at Naniachar, he was arrested by the army as a Shanti Bahini though there is no such evidence against him. After the arrest, he was immediately sent to the army camp at Barpul Para for interrogation and torturing. There after he was sent to the army camp at Thalchara for further interrogation and torturing. After completion of interrogation and torturing he was sent to the Zonal Head Quarters at Barabunnya where he is being kept under custody without bail or release.
- 34. On April 14, 1986 Betra Chakma, 25yrs, 5/0. Aush Chandra Chakma, of Chekko Para, P.S. Naniachar, was arrested by the soldiers of 26th EBR, Barpul Para camp. After interrogation and toruring he was sent to the Zonal Head Quarters at Barabunnya where he is being kept under army custody.
- 35. Pelakani Chakma, 18yrs, wife of Pelakana Chakma, of Tongtulya, P.S. Naniachar, was gang raped in her house by the soldiers of 26th EBR from the army camp at Machya Para when her husband was away from the house. She was bleeding profusely when the soldiers left her in senseless condition. She had to be taken to Rangamati for treatment.
 - On May 7, 1986 an army unit of 26th EBR from the army camp at Barpul Para, raided the Chakma village of Bakchari Thoom Adam, P.S. Naniachar, carrying out looting and beating the innocent people who refrained from casting votes in response to the call given by the JSS to boycott the May 7, 1986 general election of Bangladesh. The soldiers looted gold ornaments, money, goats, cattles, fowls worth Tk.60,000/-(Sixty thousand takas). Names of the affected persons who were also beaten by the soldiers are given below:

A communal riot took place on May 8, 1986 in Lalyaghona, Ugalchari. Tulaban, Jibanga Chara areas of Baghaichari Upazilla when army, BDR, VDP and the Bengales muslims launched co-ordinated attacks on the innocent unarmed ethnic Chakma people in which many Chakmas were wounded seriously, brutally tortured, their houses set on fire, properties looted, Buddhist temple desecrated and images of Lord Buddha wers kicked into pieces. As part of Bangladesh government's policy of systematic eviction and extermination of the ethnic Jumma (High Landers) people, in a secret meeting a decesion was taken to attack the Chakma villages. The meeting was attended by Lt.Col. Md. Jalal Abed, C.O. 41st EBR, Maj. Khairul Alam of 14th Bn (Battalion), BDR, Marishya, Humayun Kabir, adjutant of VDP, Hassan Ali, VDP commander, Amirul Karim, Upazilla Nirbahi Officer, Haider Ali, a resident near Baghaichari Upazilla office. The culprits who took active part in the violence are -

- 1. Shamsul Huda, chairman of Rupakari U.P. (Union Parishad). address - Battali, P.S. Baghaichari.
- 2. Azizur Rehman of Jibanga Chara, P.S. -do-, a contractor.
- 3. Hafiz Mohamed Majhee of Kassalong Bazar, P.S.-do-.
- 4. Asghar Ali of Ugalchari, P.S. -do-.
- 5. Sukkur, address -do-.
- 6. Balya, address -do-.
- Syed Noor, address -do-.

The attacking muslims, army, BDR and the VDP personnels shouted agitating islamic slogans - "Yah Ali", 'Nara-e-Taghdir, Allah-o-Akbar", 'No room for Kafirs, Hill Tracts for Muslims", 'By the grace of Allah(God), Save Sonar(Golden) Bangla*.

- 55. "Navjyoti Buddhist Vihara" of Lalyaghona, P.S. Baghaichari, was desecrated by the Bengalee muslims, army, BDR and the VDP personnels. All the 4 images of Lord Buddha including the one brought from Thailand were kicked and broken into pieces. The director of the Vihara, Rev. Pragga Sara Bhikshu was beaten so severely that he fainted instantly and fell on the ground. He was not even allowed to drink water, not to think of taking his morning meal. The Vihara was ransacked and all its valuable properties were looted by the Bengalee muslims and the Bangladesh forces.
- 56. Bipin Kumar Chakma, S/O. Naramya Chakma, of Lalyaghona, P.S. Baghaichari. His house was ransacked and properties looted away.
- 57. Vijay Kumar Chakma, S/O. Golok Chandra Chakma, address -do-. -do-.
- 58. Punyalal Chakma, S/O. Barpeda Chakma, address -do-. Two goats were looted away from him.
- 59: Vijay Kumar Chakma, S/O. Rogodhan Chakma, who is the chairman of U.P. Baghaichari, was also threatened with dire consequences when he tried to pacify the muslim communalists and the government forces who attacked the innocent unarmed Chakmas, looted their properties and committing rape, tortures on them.
- 60. Dinesh Chandra Chakma, S/O. Pushpamoni Chakma, of Lalyaghona, P.S. Baghaichari, was beaten with iron rod by the attacking muslims supported by the government forces when he and Vijay Kumar Chakma tried to pacify the attackers in order to save the tribals and to bring peace and normalcy in the affected tribal areas.
- 6%. Mrigendu Chakma, 5/0. Punyasen Karbari, address -do-, was threatened with life.
- 62. Ananda Charam Chakma, S/O. Kishto Charam Chakma, address -do-. He was returning from Marishya Bazar (Market) and on the way he was severely beaten by the muslims.
- 63. Laxmi Kumar Chakma, S/O. Vishnu Chakma, address -do -. This innocent person was also victimised like Ananda Charan Chakma.
- 64. Manobi Chakma, 24yrs, wife of Upendra Chakma, of Jibanga Chara, P.S. Baghaichari, was working in the garden near her house when Bengalee muslims came running and fell upon her. She was gang raped by the Bengalee muslims.
- 65. Tondo Chakma, S/O. Surya Kumar Chakma, address -do-, who is a student of tenth class, was returning home from his tutor, on the way he was rounded up by the muslims in the Upazilla ground and was beaten up severely by them.
- 66. Bhrama Lal Chakma, S/O. Kripachan Chakma, address -do-, was beaten inhumanly in his house by the Bengalee muslims.
- 67. Tando Chakma, S/O. Umesh Chandra Chakma, address -do-. He was coming home, on the way he was caught and beaten by the muslim communalists.

- 68. Dayal Kumar Chakma, S/O. Brisha Mohan Chakma, of Jibanga Chara, P.S. Baghaichari, who is an officer of Upland Settlement in the Rubber Plantation Project, was kept in confinement for more than an hour in the office of the UNO by the VDP personnels.
- 69. Nitish Dewan, S/O. Prabodh Dewan, address -do-, who is an employee of Rural Development department, was also manhandled and treated alike Dayal Kumar Chakma.
- 70. Madhav Chandra Chakma, of Uluchari, P.S. Baghaichari, was beaten severely along with three others by the BDR personnels.

 On May 10, 1986 an army contingent led by Capt. Khaleque of 26th EBR from the army camp at Barabunnya, carried out operations on the pretext of searching for Shanti Bahini in the Chakma villages Harin Ghat Chara and Nava Karbari Para, P.S. Naniachar. During the operations, many innocent people were subjected to beating, torturing and raping. A reign of terror was created on the innocent Chakma inhabitants by the barbarity of the army personnels who
- have resorted to shooting the innocent people, killing and taking the innocent people to army custody. Names of the victims are given below:

 71. Kajola Devi Chakma, 17yrs, D/O. Kshetra Bihari Chakma, of Harin Ghat Chara, Depo-Sabekbyone, D.S. Maniantan
- Chara, Deno-Sabekhyong, P.S. Naniachar, was inside her house when the soldiers surrounded the house and fired submachine guns at the house indiscriminately and she was hit by a bullet. She was taken to the Primary School, Jaduga Chara, P.S. Naniachar. The soldiers did not spare her from barbaric rape, although she was bleeding and suffering from the bullet injury. She was raped consecutively by the soldiers after which they inserted a piece of bamboo in her private parts when she was kept at the School. Oue to serious bleeding, barbaric rape and torture she died on the way when she was being taken to Naniachar hospital.
- 72. Kalpana Mohan Chakma, 17yrs, S/O. Rajmohan Chakma, address -do-, a student of tenth class, Naniachar High School, was also wounded when the soldiers opened fire at his house. He was forced to confess as being a Shanti Bahini in the wounded condition and then he was flown to Rangamati in an army helicopter for hospitalisation but due to the serious nature of the injury he was flown to Chittagong.
- 73. Ramana Mohan Chakma, 23 yrs, father's name and address -do-, a student of Rangamati College, was arrested, beaten severely and taken to army camp for further interrogation and torturing and being kept under army custody.
- 74. Paran Chandra Chakma, 24yrs, S/O. Man Kumar Chakma, aaddress -do-, was arrested, beaten and taken to army custody.
- 75. Ananda Kumar Chakma, 55yrs, S/O. Chikon Chan Chakma, address -do-, was beaten severely.

On May 25, 1986 an army unit from the army camp at Bhaibon Chara, surrounded the village Paujjya Chari, P.S. Panchari, in an operation against the Shanti Bahini and carried out house to house searches, subjecting the innocent inhabitants of the village to harassment and beatings. Two persons were seriously injured due to army beating. The names of the victims are given below:

- 116. Chitti Chakma, 26yrs, S/O. Haripada Chakma, of Paujjya Chari, P.S. Panchari.
- 117. Kalya Chakma, 40yrs, S/O. Tilya Chakma, address -do-.
- 118. On May 25, 1986 soldiers of 19th EBR from the army camp at Pradeep Para, during their road patrol intentionally fired machine gun at Kanti Chakma, of Suknachari, P.S. Panchari, wounding him seriously.

On June 7, 1986 am army lieutenant with soldiers of 41st EBR from the army camp at Marishya, surrounded the Chakma village of West Lalyaghona, P.S. Baghaichari, at midnight. Innocent inhabitants were taken out of their houses who were then beaten severely and tortured. A tribal woman was also raped in the incident. The operation was carried out on the instigation of a Bengalee muslim named Aminul Huq of Battuli, P.S. Baghaichari. Aminul Huq is an army agent and also a racist communal fanatic muslim, who is actively helping the Bangladesh army in uprooting the indigenous tribals from their ancestral homeland. Names of the victims are given below:

- 119. Dhana Chakma, 14yrs, S/D. Nagendra Lal Chakma, of West Lalyaghona, P.S. Bahaichari, was beaten severely in his house.

On June 12, 1986 two Chakma tribals were arrested by Lt. Kabir of 41st EBR, army camp, Marishya, and armed gang of Bengalee muslims. The arrested persons were taken to the army camp where they were subjected to inhuman tortures several times. They were released on June 13, 1986 after extorting Tk. 10,000/-(Ten thousand taka) from them. Names of the victims are given herewith:

- 128. Ajit Kumar Chakma, 18yrs, S/O. Chiroshanti Chakma, of Ugalchari, P.S. Baghaichari, was given electric shocks on his genitals. He was tortured several times in the army custody.

They were beaten and tortured and being kept under army custody without any trial or bail.

On June 29, 1986 an army unit from the army camp at Naniachar, called a meeting at the Primary School of Kattaltali which was attended by tribal elites of the locality. In the meeting, the army authorities bitterly criticised the movement for right of Self-determination in CHT and warned the people not to support the movement and to refrain from giving donations to the Shanti Bahini. After the meeting was over, six persons were arrested and taken to the army camp at Naniachar for interrogation and torturing. Names of the arrested persons are given below:

- 131. Mukunda Lal Chakma, 55yrs, S/O. Kalikinkar Chakma, of Bhangamura, P.S. Naniachar, was taken to the army camp at Naniachar after being arrested. At the camp he was tortured during interrogation. Later, he was given release after extorting Tk.10,000/-(Ten thousand taka) from him.
- 132. Smritimoy Dewan,45yrs, S/O. Late Madhav Chandra Dewan, of KattaItaIi, P.S. Naniachar, was also taken to the army camp at Naniachar after being arrested and was tortured during interrogation. He was given release after extorting Tk.12,000/-(Twelve thousand taka) from him.
- 133. Amar Kanti Dewan, 35yrs, S/O. Sahasra Dewan, address -do-, was also arrested and taken to the army camp at Naniachar where he was subjected to inhuman tortures during interrogation. Later, he was sent to Rangamati for further torturing and interrogation by the DGFI (Directorate General Of Forces Intelligence). His where abouts are not given to his relations by the army authorities.
- 134. Nirmalendu Khisa, 40yrs, S/O. Indra Ranjan Khisa, address -do-, was also arrested and taken to the army camp at Naniachar and tortured. He was sent to Rangamati for further torturing and interrogation by the DGFI. His relations have not been able to trace him out as the army authorities refuse to give any information about him.

- 221. Tribal villages which were looted and burnt by the Bangladesh army and illegal Eengalee muslim infiltrators in the 1st week of July, 1986,

On July 6, 1986 soldiers of 41st EBR surrounded the village Ghulchari at 0100 hrs(BST) midnight. Only those persons escaped army atrocities and tortures who managed to flee from the round up but women and young girls who could not escape were tortured and raped. The villagers who took shelter in the jungles near the village were fired upon indiscriminately by the soldiers at 0500 hrs in the morning. Due to the intentional and indiscriminate army firing on the innocent, unarmed Chakma inhabitants, one boy was wounded. All the panic stricken men and women were arrested and beaten on the spot and later taken to the army camp for torturing. After appeals made by Binanda Rakhal Chakma of Betchari, P.S. Merung, the army authorities these innocent people on July 7, 1986. Particulars of the women and girls who were raped by the soldiers of 41st EBR on July 6, 1986 and the boy wounded by army firing are given below:

- Subhodhon Chakma, Byrs, S/O. Badichan Chakma, of Ghulchari, P.S. Merung, was wounded due to intentional indiscriminate army firing on the innocent, unarmed Chakma inhabitants.
- 223. Suryalata Chakma, wife of Jayanta Kumar Chakma, address -do-, was raped.
- 224. Narambi Chakma, 17yrs, address -do-, was raped till bleeding.
- 225. Mrs. Virendra Kumar Chakma, address -do-, was raped cosecutively.
- 226. Mrs. Lalit Kumar Chakma, address -do-, was also raped.
- 227. Mrs. Navin Sen Chakma, address -do-, was raped.
- 228. Mrs. Padma Sen Chakma, address -do-, -do-.
- 229. Rongomala Chakma, D/O. Boli Chakma, address -do-, was raped till bleeding.

- 231. Kedama Chakma, wife of Kedabap Chakma, address -do-, was raped.

On July 7, 1986 a group of 23 soldiers belonging to 19th EBR from the army camp at Nalkaba, raided the Chakma village Kuradia Chara, P.S. Panchari, torturing and beating the following persons severely:

- 235. Sudipto Chakma, 22yrs, S/O. Binodbal Chakma, of Kuradia Chara, P.S. Panchari, was hung upside down and had water forced into his mouth and nose.
- 236. Einodbal Chakma, 47yrs, S/B. Gyanendra Chakma, address -do-, was kicked to the ground and beaten with bamboos.
- 237. Gacchyo Chakma,35yrs, S/O. Kiran Chandra Chakma, of North Nalkaba, P.S. Panchari, was beaten severely with an wooden block.
- 238. Dev Ranjan Chakma, 23yrs, S/O. Indu Kumar Chakma, of Kuradia Chara, P.S. -do-, was beaten and tortured inhumanly.
 - On July 7, 1986 Major Sharif and Subedar Akhtar of 30th EBR from the army camp at Betchari Mukh, raided the Chakma village of Betchari Mukh, P.S. Khagrachari, with their troops when Bengalee muslim infiltrators of Betchari Mukh after setting fire on their own houses reported to the army commander that Shanti Bahinis have attacked them. This was totally ill motivated against the innocent tribal people to uproot them from their ancestral lands through conspiracy and collusions. The army personnels came with vengeance and created reign of terror including raping of tribal women. Names of the victims are given below:
- 239. Uday Chandra Chakma, 32yrs, S/O. Kaviraj Chakma, of Betchari Mukh, P.S. Panchari, was beaten severely for being unable to give them informations about the Shanti Bahini.
- 240. Manoranjan Chakma, 38yrs, S/O. Rizav Chandra Chakma, address -do-, was falsely accused of giving donations to the Shanti Bahini and beaten severely with submachine gun butts.
- 241. Palokya Chakma, 20yrs, S/O. Dinabasu Chakma, address -do-, was beaten severely. While being beaten by the soldiers, he was asked when he joined the Shanti Bahini, when did he undergo training in the Shanti Bahini, etc. He was made senseless due to severe beating.
- 242. Ramkrishna Chakma, 30yrs, 5/0. Kali Mohan Chakma, address -do-, was beaten severely by the army personnels who falsely charged him as a Shanti Bahini.
- 243. Chibachogi Chakma, 14yrs, D/G. Kalo Chakma, address -do-, was raped by the soldiers.
- 244. On July 9, 1986 Binanda Rakhal Chakma (Rakhal Mohajan), S/O. Sundajjya Chakma, of Ghulchari, Betchari, P.S. Merung, was kidnapped by Bengalee muslim infiltrators when he was returning home from the market alone. Since then he is still missing and it is heard that he has been secretly murdered by the infiltrators.
- 245. On July 9, 1986 Somendra Chakma, S/O. Kishto Mohan Chakma, of Kripapur, P.S. Dighinala, was shot to death by the army personnels in his house.

- 200. On July 10, 1986 Lt. Iftekharuddin Ahmed of 7th EBR from the army camp at Rangapanichara, carried out operations in the village Swarna Kumar Para and arrested two innocent persons who were beaten severely and taken to army custody. The victims are:
- 246. Smriti Kanti Chakma, 18yrs, S/O. Lalit Kumar Chakma, of Swarna Kumar Karbari Para, P.S. Merung.
- 247. Tongo Chakma, 28yrs, S/O. Dhal Moni Chakma, address -do-.
 From July 10 to 13, 1986 a unit of 26th EBR under the command of Captain Sultan from the army camp at Baranachari, P.S. Löngudu, carried out operations in the Chakma village of Ukchari, P.S. Longudu, on a pretext of searching out the Shanti Bahinis. During the operations, Bangladesh forces resorted to looting of tribal properties. Names of the victims whose properties were looted by Bangladesh army personnels are given below:
- 248. Rajendra Chakma of Ukchari, P.S. Longudu. The soldiers looted away 2 goats and 4 fowls from him.
- 249. Ananda Mohan Chakma, address -do-, was forced to give the attacking soldiers 1 bullock and 3 fowls free of cost otherwise he would have lost his life.
- 250. Pramod Chandra Chakma, address -do-. The soldiers looted his house and took away 7 blankets, 1 shaul and a mirror.
- 251. Chandra Dhawj Chakma, address -do-. He had a ripe row of plantains which he kept for selling in the market. The soldiers at gun point ate up all his benanas and threw banana peels at him.
- 252. On July 11, 1986 illegal muslim infiltrators made ammarmed robbery in the house of Kamala Kanti Chakma, S/O. Binanda Rakhal Chakma, of Ghulchari, Betchari, P.S. Merung, looting all his properties including gold, silver ornaments, cattles, goats amounting Tk. 50,000/-(Fifty thousand takas).
- 253. On July 11, 1986 illegal muslim infiltrators of Roshik Nagor Para attacked the Chakma village of Ghulchari Mohajan Para, P.S. Merung, with deadly weapons shouting Islamic and communal slogans such as 'Yah Ali', 'Allah-O-Akbar', 'Down with Kafirs', 'We want Chakma blood', 'Chakmas go away', etc. and carried out looting and arsoning in the village creating panic among the Chakmas who had to take shelter in the jungles to save their lives from the attacking muslim hordes.

On July 11, 1986 an army unit of 45 soldiers from B Coy (Company) - 7th EBR from the army camp at Korolya Chari, commanded by Captain Khatem Ali, attacked the Chakma village of Deno-Atarakchara, P.S. Longudu. The whole village was encircled by the soldiers who then fired light machine guns and sub machine guns indiscriminately and shelled the village with 60mm mortars. The following persons who were arrested from the village, were subjected to inhuman tortures and beating. They were taken to the army camp at Korolya Chari and being kept under army custody without bail:

- 264. On July 11, 1986 a large crowd of illegal Bengalee muslim infiltrators attacked the Chakma villages of Bor Kangara Kheiya, Natun Chandra Karbari Para, Manik Chandra Karbari Para, P.S. Longudu, looting all the properties including cattles, fowls and set fire on 50 houses. On July 12, 1986 five Chakma tribals of Rangei Para and Guicharil Mukh were murdered by illegal Bengalee muslim infiltrators. The victims were returning home from Boradam, P.S. Longudu, with paddies which they borrowed from their relations. On the way, they were rounded up at a place in between Boiragi Bazar and Gulsakhali by a gang of illegal muslim infiltrators who after robbing murdered these innocent tribals. Names of the victims who were murdered by the muslim
- 265. Surya Bala Chakma, 35yrs, D/O. Mukunda Lal Chakma, of Rangei Para, P.S. Longudu.
- 266. Sudhir Chandra Chakma, 45yrs, S/O. Uttara Kanta Chakma, of Pedanyama Chara, P.S. -do-.
- 267. Ram Chandra Chakma, 35yrs, S/O. Khatya Chakma, of Guidhari; P.S. -dd--.
- 268. Fanendra Chakma, 30yrs, S/D. Tagara Chakma, address -do-.
- 269. Bharat Mohan Chakma, 16yrs, father's name and address -do-.
- 270. On July 18, 1986 at 0100hrs(BST) midnight the VDP personnels of the surrounding settlements of the infiltrators near the army camp at Sonai, P.S. Longudu, in a bid to make a ground for attacking the Chakma villages, fired towards the Chakma villages on a false pretext of being attacked by the Shanti Bahinis. The Chakma inhabitants had to take shelter in the jungles to save their lives. The tribal leaders lodged a complaint with the army authorities that the firing incident was a motivated design of the infiltrators to create communal riots and to uproot the tribals from their ancestral lands. After an inquiry, it was found that the firing incident was pre planned by the VDPs as there was no presence of Shanti Bahinis in the Chakma villages when the incident occured. The army authorities took no action against the VAP personnels for their wantonly act.

- 271. On July 20, 1986 Anil Kumar Chakma, 30yrs, S/O. Jubo Laxman Chakma, of Bamo-Atarakchara, P.S. Longudu, was attacked by the VDP personnels—Abdul Khaleque and Syedul. The victim was in his plough land when the culprits came and attacked him. He was threatened of life if he would not leave the lands that he cultivates. Reports say that Lt. Saif of 7th EBR from the army camp at Korolyachari, is instigating and helping the Bengalee muslim infiltrators to occupy the tribal lands illegally and by force.
- 272. Gopadevi Chakma, 16yrs, D/C. Krishna Laxman Chakma, address -do-, was raped by the VDP personnels Abdul Khaleque and Syedul in the paddy field she was working. The culprits tied her hands and put a handkerchief in her mouth and raped her.

On July 21, 1986 six Chakma tribals of Jibanaswa Para, P.S. Panchari, were secretly murdered by Bengalee muslim infiltrators of Shontilla, P.S. Panchari. The illfated victims were returning home from the market. It was 1200hrs (BST) when they arrived at Shontilla where they were rounded up and murdered by the Bengalee muslim infiltrators. There was also a young Chakma girl with those victims whom the infiltrators gang raped and she was about to be killed when one of infiltrators wanted to convert her to Islam and marry her by force. The muslim infiltrator who already has a wife, took the Chakma girl to his house. But the wife of the infiltrator helped this Chakma girl to escape. When the girl returned home and told the villagers about the incident the matter was reported to the Zonal army commander, Panchari. An army investigation team was sent and the girl identified the culprits but no action was taken against the murderers. It is now clear that Bangladesh army is encouraging the illegal Bengalee muslim infiltrators to indulge in the secret killing of the tribals. Names of the victims are given below:

- 273. Jatindra Chakma, 32yrs, S/D. Monchan Chakma, of Jibanaswa Para, P.S. Panchari, was murdered by the Bengalee muslim infiltrators.
- 274. Monchan Chakma, 65yrs, S/O. Sambhunath Chakma, address -do-, -do-
- 275. Amar Chakma, 40yrs, S/O. Pokka Chakma, address -do-, -do-.

- 280. On July 30, 1986 Mrittunjoy Tripura, 32yrs, S/O. Danta Roy Tripura, of No.3 Rubber Plantation Project, Ghulchari, P.S. Merung, was secretly murdered by illegal Bengalee muslim infiltrators of Merung while he was returning home alone from the market.
