in Chittagong Hill Tracts committed by  
Bangladesh army, para-military forces  
and Bengalee muslim infiltrators.

(JAN.I990 - DEC.I990)

02-5 JAN.90 : Bangladesh army personnel from Khagrachari,  
Baranal Camp, Bet Chari Camp, led by Major Hassan, 25 EBR, carried  
out massive operations in Kamalchari and Kudukchari Jum cultivation  
(slash and burn cultivation) areas with a view to harrass and to  
cripple the Jumma inhabitants economically. Almost all the houses  
and properties were destroyed by the army personnel who set on fire.

During the operation, innocent Jumma men, women and children were subjected to physical tortures. A Buddhist monk of Rupakari Buddha Vihara was assaulted and five other persons were arrested. 05 JAN.90 : Bangladesh army personnel of 29 EBR, Baghaichari Zone, in collusion with Bengalee muslim infiltrators, raided the Jumma village - Jibtali, P.S. Baghaichari. During the raid, the army personnel resorted to looting of cash and arrests. Tk. 50000/- (fifty thousand taka) were looted from the inhabitants and twenty five innocent persons were arrested on false charge of being Shanti Bahini who were subjected to inhuman beating.

06 JAN.90 : Lt. Col. Mustafizur Rahman, CO, 29 EBR, Zonal Commander, Baghaichari Zone, declared total ban on Jum cultivation within Baghaichari Upazilla and ordered the Chakma inhabitants to shift to Gucchagrams with immediate effect or else they would face dire consequence.

06 JAN.90 : Bangladesh army personnel of Mahalchari Zone, arrested an innocent person on pretext of marketing for the Shanti Bahini at Mahalchari Bazar. The victim —

31. Mr. Batya Chakma, 35 yrs, son of Mr. Paranya Chakma, of Dajya Para, No.78 Kengelchari Mouza, P.S. Mahalchari.

07 JAN.90 : Major Mashiur Rahman, 32 EBR, Sub-Zonal Commander, Laxmi Chari, during a raid against Jumma inhabitants, resorted to arsoning. The victims —

32. Mr. Parimal Dewan, 38 yrs, son of Mr. Batalya Dewan, of Dewan Para, Dulyatali, P.S. Laxmi Chari. 20 quintals of paddy were looted from him and his house was set on fire.

II JAN.90 : Lt. Col. Zillur Rahman, CO, Merung Zone, arrested an innocent Jumma person on pretext of helping the Shanti Bahini. It may be referred that on 22 NOV.89 the army suffered casualty in an encounter with the Shanti Bahini. The victim —

Three innocent persons were arrested from their houses at dead of night. They were charged with false allegation of being Shanti Bahini. They are still detained at Khagrachari. The victims —

I4 JAN.90 : Lt. Col. Shafayet, CO, 27 EBR, Bangladesh army, Matiranga, in conspiracy with Mr. Milan Kanti Tripura, a member of the so-called Khagrachari Hill District Council, ordered an innocent Jumma person to report at the army camp. The innocent person was charged with keeping contact with the Shanti Bahini and not supporting the Hill District Council. He was subjected to inhuman beating and tortures. The victim —
