 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Tohono O'odham Citi-

- 2 (a) IN GENERAL.—Chapter 2 of title III of the Immi-
- 3 gration and Nationality Act (8 U.S.C. 1421 et seq.) is
- 4 amended by inserting after section 322 the following:
- 5 "ENROLLED MEMBERS OF TOHONO O'ODHAM NATION
- 6 "Sec. 323. (a) Granting of Citizenship.—A per-
- 7 son who is listed on the official membership roll of the

- 9 Indian nation located in Arizona, is a citizen of the United
- 10 States as of the date on which such listing occurs.

- Notwithstanding any other provision of law, the valid
- 23 membership credential issued to a person who is listed on
- 24 the official membership roll of the Tohono O'odham Na-
- 25 tion pursuant to the laws of the Tohono O'odham Nation

2	law, equivalent to—
3	(1) a certificate of citizenship issued under sec-
4	tion 341(a) of the Immigration and Nationality Act
5	(8 U.S.C. 1452(a)) to persons who satisfy the re-

(2) a State-issued birth certificate.
