LODGING OF FORMAL COMPLAINT AGAINST
MAUI POLICE DEPARTMENT AND OFFICERS

Re: Majesty Akahi Nui, Akahi Wahine, Terry N. Kaahanui

The following is a formal complaint that I would like to have an investigation conducted upon immediately. The activity of the officers over which you have charge is threatening Me and My Queen's life and limb, with terroristic acts of threatening, attempted kidnap and endangerment to Me and My Family. Here is a listing of the chain of events which conveys only the most recent set of attacks upon Me, My People and My Family. But for purposes of efficiency and clarity, I would like you to focus only on this most recent incident for now.

On the ^{CC-1} (twenty-fourth day) of the Tenth month in the Holy Year of our Akua One Thousand Nine Hundred and Ninety Seven, in the Ahupua'a of Kanaio on the burial site of Halemano (k), the fifth great grandson of Keouakipuapaikalani (k) and Akahi Nui (w), at 5:18 p.m., three unidentified males pulled up and sat in a white four door Isuzu vehicle parked within the boundaries of My land, Royal Patent 2799 on the Mauka side of the King's Trail Road. These individuals did not identify themselves as law enforcement officers with either a badge or identification card as required by MAUI POLICE DEPARTMENT Procedure, and were dressed in plain work clothes, with the front seat passenger wearing a black tank top and blue jeans, making them not at all appear like law enforcement officials, thus violating their own procedure.

As I approached the vehicle to see who they were and what they wanted, the driver shouted an order to his passengers; ("NOW!") At which point they they all quickly got out, revealing the pistols strapped to their gunbelts. With coercive force they painfully strong-armed My arms behind My back and placed handcuffs on Me, at which point they attempted to drag me off My property. As this for all Intents and Purposes could only be construed as an attempted kidnap, I quickly asked who they were and where was their arrest warrant. Not identifying themselves, they stated they had no warrant for arrest.

At this point to protect My life and limb, I quickly jumped back away from them to save Myself, and even though this whole incident occurred on My rightful property, I jumped

back even further onto the land. At this point they quickly left to avoid further identification. As this event occurred, My wife Akahi Wahine and others took pictures identifying these individuals and their vehicle. They are officers Kumo'o, Rodriguez and Rohust. Then I went further back into the land and removed the handcuffs, which I am now keeping as Kingdom of Hawaii Government property as an exhibit of evidence, along with the photos of the incident.

The next attack occurred on the Third Day of the Eleventh Month of the Holy Year of our Akua One Thousand Nine Hundred and Ninety Seven, on the right side of the International House of Pancakes in Kahului, three uniformed officers approached Me, Majesty Akahi Nui and Her Highness Akahi Wahine. Not identifying themselves, when we inquired if they had a warrant for our arrest, they said they did not have one. At that time Her Highness Akahi Wahine attempted to photograph this incident, and was forcibly stopped from doing so.

She then went into Kinetsu International, next to the International House of Pancakes, and an officer with an embroidered name of R. Duchane followed Her in. As She entered, she approached a Yuko S. Whelock and said; "Please can I use the phone, I need to call for help. As she called 911 for an emergency assistance, officer Duchane grabbed the upper part of the phone receiver along with Her hair and slammed it into Her right lower jaw, saying; "You can't make no calls for help". This resulting strike of a blow to Her head with a phone receiver caused Her to then place a chair between Herself and the six officers who were now threatening around Her, to which she replied; "I'm not going to let you do that to me again, I'm going to defend Myself." The officers forced the chair away, and all six officers piled up on top of Her on the cement floor as she was attempting to defend Herself from this unwarranted detainment.

This resulting attack has caused vertebrae damage to her spine, which she now requires prescribed medication to ease the pain from. One of the officers are also saying that she scratched his neck, so they are attempting to place bogus charges of terroristic threatening upon her. At which point they are now saying that they want to put us away for seven years, and which these most recent incidents are now being heard by a "secret grand jury" whereby they come out and tell you the decision they have unilaterally decided without any proper legal judicial process involved whatsoever. We have also now discovered that they want to charge Her Highness and our good friend and Kanaka Maoli Citizen/Subject Terry Kaahanui with bogus charges of theft of property (of the handcuffs that they themselves placed upon Me, not them!)

The officers names are; Lt. Gary Yabuta, Sgt. Roger Duchane E-0297, Sgt. Sterling Kiyota, D. Leffler E-1917, Pladera, and J. Bowker. This whole case stems from the bogus charges of trespassing on My own land, Royal Patent 2799, known under the Tax Map Key as TMK 2105-7, and which was granted to My mother under Probate No. 348SE. I am still trying to get a straight answer from those involved as to how they think they can place fraudulent trespassing charges upon Me for trespassing on My own land, since I have NEVER accepted any remuneration at all from My property or its alleged sale, and

which there is blatant and documented fraud in both the title documents AND the ensuing case which was participated in by a one Thomas Leuteneker, of Carlsmith, Ball, Wichman, Case and Ichiki law firm. They are also being named in this contingent judicial process.

This is obviously a set-up designed to detain and prevent Me from conducting the lawful affairs of business that I must continue with towards the assumption of My Office by Me, the King of the Kingdom of Hawai'i, in order to postpone the charges that will obviously be levied against them and all other members of the de-facto STATE OF HAWAII. The continuous committing of these heinous crimes against Me, My Queen and My People will now be revealed for all to see. Your full cooperation in this matter is strongly recommended, so that you will not be dragged into this process of the restoration of true justice here in My lands of Hawai'i through collusion. I take it that, from the integrity of your office and the oath you must obviously obey, that you will fulfill the responsibilities of that office to the fullest extent of the law. We have heard from confidential sources that a certain U.S. HAWAII SENATOR and Maui County Mayor Linda Crockett Lingle is secretly issuing orders to cause the MAUI POLICE DEPARTMENT, probably certain intelligence units, and other unidentified individuals to stalk and harass My Queen and I to the threat of our life and limb.

I would very much recommend a response within five days of receipt of this letter. If no response is received from you in that time, then this process will continue onward to jurisdictions over which you have no control, and this will serve as official Notice that you have been properly notified and the process of domestic remedy has been duly fulfilled.
