Aloha Mr. Albert N. Moskowitz,

I, Her Highness Akahi Wahine aka Grace Akahi, brings this informative information in full disclosure to your office the United States of America Department of Justice of Civil Rights. In reference to the ill-mannered actions of the acting Police Officers of your governments.

On the evening of the 24th day of October 1997 at or about 5:15 p.m. in the Ahupua'a of Kanaio on Royal Patent number 2799 the last rites of the Ali'i Nui Konohiki of Kanaio Halemano (k) and his wife High Chiefess Muolu (w). Ali'i Nui Konohiki Halemano (k) is the fifth great grandson of Keouakipuapaikalnai (k) also known as Keoua and Akahi Nui (w) Keoua is the father of Kamehameha. And Keoua and Akahi Nui is the great great grandparents of my husband HRM Akahi Nui and they are my great great great granduncle and aunt (maternal side) Grandmother Grace Kupa (w), great grandparents Kupa (k) and Haili Liili, great great grandparents, Ka Paki (k) and Haili Nui (w). His Royal Majesty Akahi Nui, our grandchildren, children and I. We have a royal family cultural custom giving ke ho'okupu and Mo'okuahau. Their spirit lives on this sacred aina land.

Three unidentified males pulled up and sat in a white unmarked four door Isuzu 4x4 vehicle parked within the boundaries of HRM Akahi Nui a lawful heir to Royal Patent 2799 Alodio land patent given by King Kamehameha III 1848. see exhibit "A" On the mauka side (mountain side of the trail) king's trail. These individuals did not identify themselves as law enforcement officers with either a badge or identification card as required by Maui Police Department Procedure, and were dressed in plain work clothes, with the front seat driver wearing a black and grey stripe t-shirt and blue jeans, front seat passenger wearing a black tank top and blue jeans, and the back seat passenger behind of the front seat passenger wearing a aqua blue t-shirt and blue jeans, making them not at all appear like law enforcement officials, thus violating their own procedure.

painfully strong-armed HRM Akahi Nui (husband) arms behind his back and placed handcuffs on him, at which point they attempted to drag him off his property. As I witnessed the event I kindly ask the three unidentified males I was allowed to take still photo's of the event as they proceeded one of them said "yes take all the photo's you want" There was no signs of law enforcement badges visible or publicly exposed. HRM Akahi Nui, asked what are your names? "We are here to arrest you". If this is an arrest what is the reason for it? Where is the arrest warrant? They stated we have No Warrant for this arrest. As the intents proceeded and proposes could only be construed as an attempted kidnap.

As the three unidentified males was pulling on the right arm and on the left arm like as if he arms was like a rope and they were pulling with ill-manner in great force on both arms as **tug a war**. The three unidentified males later removed their hands from HRM Akahi Nui and he walk a few steps to re-enter the last rites of **Ali'i Nui Halemano (k) Ke Konohiki Ahupua'a o Kanaio** son of High Chiefess Akahi (w) and Kahope (k). The unidentified three males just stood and watch HRM Akahi Nui with his hands in handcuffs placed in the back of him. Re-entering into the sacred land of the last rites of Ali'i Nui Halemano (k). They ( three unidentified males) made no verbal statements and returned back to the white unmarked four (4) door 4x4 Isuzu and started the vehicle and left and never came back. Left HRM Akahi Nui in their handcuffs. Made no attempts to get him or remove their handcuffs from his hands. We removed the handcuffs from HRM Akahi Nui's wrist at or about 10:30 p.m. that same night the unidentified males did not return at all.

On the 3rd day of November 1997, at or about 3:30 p.m. the next attack occurred in the Maui Mall fronting Kintetsu International Establishment HRM Akahi Nui and I, one uniformed Police Officer Lt. Gary Yabuta approached HRM Akahi Nui. In the past we did report him to the Chief of Police Howard Tagomori for misconduct mocking, verbally abusive, opprobrious, insulting, ridiculing, humiliating, malevolent, cantankerous, sarcastic, to our grandchildren, children and HRM Akahi Nui and I. And not following orders given to him by Asst. Chief Charles Hall. Lt. Gary Yabuta was ordered to make a personal apology to HRM Akahi Nui for his misconduct of mocking our grandchildren, children and I. We also reported this misconduct and this attack on 3rd day of November 1997 to the Acting Mayor Richard Haake.

As Lt. Gary Yabuta makes his approach towards HRM Akahi Nui I noticed a small hand size radio in his hand is placed over his mouth as his approach has gotten closer his right hand returns to a downward position. I then see two (2) Police Officers approaching one (1) from the south side of the building and the other from the north side of the building. Lt. Gary Yabuta then makes a statement "Hey James (HRM Akahi Nui) I think there is a warrant for your arrest" I at this point due to pass experience with this Lt. Yabuta knew it was a repercussion happening at this time (personal apology Lt. Yabuta was ordered to make to HRM Akahi Nui) as I took a few steps I saw HRM Akahi Nui getting manhandled in a malevolence in Lt. Gary Yabuta face and Sgt. Sterling Kiyota headlocks and punching pounding force downwards on the back of HRM Akahi Nui's head and back by the two Police Officers, I then got into Kintetsu International Establishment ask to use their telephone to make a 911 call for help. I went into a narrow place where one person could stand to use a desk like shape telephone I picked up the receiver with my right hand and dialed 911 with my left hand. A hand with great force grabbed the upper part of the phone receiver along with my hair from the right side of my head slammed it

into my right side of my face "YOU ARE NOT MAKING THIS 911 CALL". A right hand reaching between my right breast and right shoulder with major force pulling me back away from the phone slamming my whole body into a divider and wall. At this point I was in severe pain in my head, face and neck I at this point thought I was going to die. I have a right temporoparietal craniotomy on my right side of my head. As I looked up I saw embroidered name R. Duchane. Sgt. Roger Duchane stated No 911 calls and I replied I'm not going to let you hurt me again" I then placed a chair between Sgt. Roger Duchane and myself. During the time of the attack by Sgt. Roger Duchane there was no one in this establishment.

By this time Lt. Gary Yabuta comes in with Sgt. Sterling Kiyota and heads towards me I start to walk backwards against a conference room wall. Now at this time Police Officers are coming in J. Pladera, D. Leffler E-1917, and J. Bowker. Now there are six (6) male Police Officers. Lt. Gary Yabuta now attacks me by getting hold of the chair forces it into my stomach and chest, one Officer pulls the chair from Lt. Gary Yabuta, the other officer clasp my face, head and shoulder towards the wall with malevolence slams my face and body onto the concrete floor. Sgt. Roger Duchane contract his right knee on to my head and contract his left knee on to my neck with full body weight on both knees. At this time some of the other officers are on my back and my legs forcing their hands under my private areas and some forcing their hands up towards my breast rubbing area it "Can't get her hands" laughing.

They than place my hands in their handcuffs then grab my shirt torn it and pulled me off the floor. As they got me to my feet they started to walk me out of the establishment I plead with the Officers to pull my blouse down my breast was exposed and they refused to pull my blouse down. They mocked me as they exposed me to the public with smiles and grins saying thank you for the overtime. As I was placed in Officer D. Lefflers patrol car I told him (Police Officer D. Leffler E-1917) what had happen to me and how it started I made 911 call and I was attacked by Sgt. Roger Duchane . Officer D. Leffler stated he has to do what the big guys says he is just a little guy.

At the Police Station I was in serve pain from my head to my legs I was badly beaten. I told Sgt. Ching about my craniotomy and the pain is so caustic she looked at me with repugnance. During the time of incarceration for one night I was taken to the courtroom the next day. I told the sheriff of my caustic pains towards my head and back he stated "If we take you to the Doctors now you will remain in custody till tomorrow for court". So proceeded to the Doctors after court.
